About the Foundation

The Stefan Batory Foundation, established in 1988 by George Soros, an American financier and philanthropist, and a group of Polish opposition leaders of 1980s, is an independent, private foundation registered as public charity under Polish law. The mission of the Batory Foundation is to build an open, democratic society – a society of people aware of their rights and responsibilities, who are actively involved in the life of their local community, country and international society. Our priorities include:

improving the quality of Polish democracy

We support initiatives aimed at increasing civic participation and strengthening citizens' sense
of responsibility for the common good. We are committed to transparency in public life and to
promoting social oversight over the functioning of public institutions. We seek to raise the level
of public debate and to "socialize" the process of making and implementing public policies.

strengthening the role of civic institutions in public life

 We support the development of non-governmental organizations and coalitions working to improve the quality of Polish democracy and expand international cooperation. We seek to professionalize and legitimize their activities, build up their credibility, and increase their influence on the public sphere.

developing international cooperation and solidarity

 We are committed to closer ties between European Union states and the EU's eastern neighbors, especially Ukraine and Belarus. We support activities that encourage exchange of experiences connected with the processes of political transition, building civil society, and solving social problems among the countries of Central and Eastern Europe. We seek to enhance the role of Polish NGOs in the international arena.

Foundation undertakes also activities aimed at equalizing educational opportunities of young people from poor communities.

The basic method of the Foundation's operation involves making grants to non-governmental organizations engaged in public benefit activity in Poland and in Central and Eastern Europe. We also carry out - alone or in partnership with other organizations – in-house projects: we host public debates and conferences, organize study visits, seminars and workshops, issue publications, run social campaigns, engage in monitoring of public institutions and advocacy efforts.

The Foundation partners with many institutions from Poland and abroad. It is a member of Polish Donors Forum, Polish NGOs Abroad, the European Foundation Centre in Brussels, Eastern Partnership Civil Society Forum at the EU–Russia Civil Society Forum.

In our activity we observe principles of transparency and accountability. Up-to-date information on our activities and grant-seeking opportunities is posted on our website www.batory.org.pl. Our finances are audited by professional auditors and the financial statements are published in the Annual Report, together with the list of grants awarded and projects implemented during the year.

Our Donors

We carried out our activities in 2014 mainly from grants from Polish and foreign private and government institutions, from donations and gifts made by companies and individuals and from the 1% personal income tax contributions.

With funds received from the European Economic Area Financial Mechanism (so called EEA Grants) we carried out Citizens for Democracy programme planned for 2014-2016. This programme with a budget of EUR 37 million offers grants to Polish non-governmental organisations for initiatives in the area of civic participation and civic scrutiny over public institutions, counteracting discrimination and social exclusion and initiatives targeting children and youth.

The remaining programmes were funded mainly from grants received from the Open Society Foundation and from the Foundation's own resources. With grants from the National Endowment for Democracy, the European Commission, the Centre for Polish-Russian Dialogue and Understanding and from the Solidarity Fund PL we financed part of activities undertaken within the Open Europe programme.

The donation made by the Agora Foundation, the revenues from the Małgorzata Szejnert Fund, the funds granted by the Quo Vadis Gavell Family Foundation and the 1% income tax contributions financed grants to organisations running scholarship programmes aimed to equalize education opportunities of youth in rural areas and low-income families. We secured PLN 80,000 in donation from the Pracuj.pl group to support the Equal Opportunities programme in 2014 and a bequest of PLN 240,000 in the form of investment fund participation units from Elżbieta and Zbigniew Sadowski.

With monies accumulated in three donor advised funds: Iwona Winiarska-Feleszko, Janina & Tomasz Maczuga and J&J Putka Spread Your Wings Funds we funded scholarships for university students. Through the Beata Pawlak Fund we funded annual award for publication on foreign cultures, religions and civilizations. The Sing Staszek Jonczyk Fund supported amateur choirs. From the donation made by the US-based Karol Uryga-Nawarowski Foundation we provided grants to organisations which provide diagnosis and therapy for children suffering from the Fetal Alcohol Syndrome.

We wish to thank all our donors: individual, private and corporate for their continuous support. We express our gratitude to hundreds of Polish taxpayers who chose our Foundation as a beneficiary of 1% of their income tax. With your help we can help others!

We thank companies and institutions that provided us material and non-material assistance as well as experts and consultants who served us pro bono with their professional advice and support.

The Foundation 2014

We carried out our activities within nine domestic and international programmes. Three of them provided financial support to non-governmental organisations in Poland (Citizens for Democracy, Equal Opportunities) and abroad (For Belarus). In the remaining six (Debates, Your Vote, Your Choice, Public Integrity, Open Europe, Regional Alcohol and Drug Programme, ECFR Warsaw Office) we carried out our own projects.

In the domestic programmes, particular emphasis was placed on developing and supporting initiatives seeking to improve public participation to create more opportunities for citizens to get involved in the legislative and public policy process at the local and national level, exercise public scrutiny over public institutions, engage community members in local decision-making and promote informed and active voting in elections. Much attention was given to discrimination, social exclusion and youth and children initiatives.

We put a lot of energy and work into the implementation of the Citizens for Democracy grant programme launched in mid-2013. This PLN 150 million programme funded from the European Economic Area Financial Mechanism (EEA Grants) made us for three years the largest donor for the non-governmental community in Poland. The scale of the programme illustrate the following figures: calls for project proposals held since the autumn of 2013 attracted 6,676 applications. Over 100 external experts were involved in the two-tier assessment and selection process. The three calls for proposals completed in 2014 resulted in 354 grants totalling PLN 81 million for projects related to public participation, civic scrutiny, counteracting discrimination and social exclusion, as well as activities targeting children and youth, and 9 grants of a value of PLN 3.5 million for systemic projects, which aimed at developing and implementing measures to improve the quality of the functioning of the Third Sector. In addition, 34 organisations received grants totalling PLN 0.8 million to support the development and strengthening bilateral partnerships between organisations in Poland and in the European Economic Area countries. As a part of technical assistance for the applicants and grantees of the programme we organised 38 meetings and workshops designed to help them develop the concept of project, plan, implement and account for projects activities. Altogether 1,149 NGO activists participated in theses meetings.

In Your Vote, Your Choice programme we continuedd activities aimed to engage citizens in public life at the local and national level. With two elections scheduled for 2014, we focused our attention on improving voter turnout. We organised two national get-out-the vote campaigns: before the European

election (25 May) and before local elections (16 November). Both of them had an objective to prevent decline in voter turnout numbers. The local elections campaign informed citizens about the powers vested in local governments in Poland, encouraged local leaders to run as candidates and voters to make informed choices having learned about the candidates' track record and programme. Despite the decline in voter turnout in European elections across the continent, the turnout numbers in Poland shrank only by a fraction compared to 2010 and were higher than in the first European elections after Poland joined the UE in 2004. A slight uptrend was achieved in the Polish local elections. Also, more local community leaders ran for office from non-party committees than in local elections four years ago.

Within **Your Vote, Your Choice** action organized since 2006 we encouraged local non-governmental organisations and informal groups to engage in initiatives aimed at strengthening active citizenship, forming partnerships with local governments and integrating communities around local problem-solving. This time the participants were offered a choice between four activity scenarios: local community needs assessment, developing a local consultations mechanism, introducing participatory budgeting at the local level and – because of the upcoming local election – mobilisation of voters to make informed election choices. The participatory budgeting, which we have been intensely promoted in our programme, turned out to be a great success: in 120 Polish municipalities residents decided on the allocations of a portion of their municipal budgets. Our guidebooks, *Participatory Budgeting, ABC of Active Citizenship, Activist's Toolbox* were popular among local community leaders. The cooperation of programme experts with the Olsztyn city authorities helped ensure a ruling by the Supreme Administrative Court that confirmed the right of local governments to independently decide on ways of executing residents legislative initiative powers.

On the eve of the **25**th **anniversary of Poland's first free elections** we joined efforts to organize civic celebration of this democratic festivity. We provided funding to the secretariat of the NGO 89 Together Coalituon and launched a call for proposals for local initiatives that commemorate the 1989 election (Other Grants). We also organised two conferences addressing the pros and cons of the political and economic transition in Poland and the achievements and failures of the past 25 years in the country: *Polish Dilemmas on the 80th Anniversary of the Birth and the 10th Anniversary of the Death of Jacek Kuro*ń, and *About the Critique of the 3rd Republic of Poland: Celebrating the Anniversary of the 1989 Transition* (**Debates**).

In the **Public Integrity** programme, we concentrated on activities aimed to ensure transparency in the legislative process and open it up to the voice of citizens, reduce the risks of corruption, nepotism and cronyism related to conflicts of interest in public life and strengthen the role and legal protection of whistleblowers. We undertook a number of monitoring and advocacy efforts to this effect. We examined to what extent the modified system of Regulatory Impact Assessment (RIA) affected the quality of legislation and the public consultations and whether the new Rules of Procedure of the Council of Ministers improved the standards of the public consultations process. In order to assess the conflict of interest at the local level we looked into the scale and nature of personal links of local council members and we evaluated the effectiveness of internal conflict of interest policies in central government offices: the Chancellery of the Prime Minister and 18 ministries. Reports and recommendations from monitoring were presented to a number of conferences, expert seminars and meetings with public administration officials. They were received with great interest by the general public and professionals.

In the **Equal Opportunities** programme, we continued to support initiatives designed to ensure equal access to education for children and youth in low-income families. Forty local organisations running scholarship programmes for school children received grants of the total value of PLN 520 thousand. Our grants, increased by funds raised by the organisations from other sources helped to fund 779 scholarships for the school year 2013/2014. Funding for this programme was made possible due to donations from individuals and companies and 1% personal income tax contributions.

In the past year, we administered **8 donor advised funds**. Most of them focused on scholarship assistance for students and graduates from secondary schools from low-income families (**Małgorzata Szejnert Fund**, **Quo Vadis Gavell Family Fund**, **Janina and Tomasz Maczuga Fund**, **Iwona Winiarska-Feleszko Fund**, **K Fund** and **J. and J. Putka Spread the Wings Fund**). The **Karol Uryga-Nawarowski Fund** supported organisations focusing on diagnosing and treating children suffering from disorders caused by FAS (Fetal Alcohol Syndrome). The **Beata Pawlak Fund** funded the 12th edition of the Beata Pawlak award for authors writing about other cultures, religions and civilisations. The **Staszek Jonczyk Sing Fund** supported the development amateur choirs.

In our **international activities**, we concentrated on developing interactions between Poland and its immediate neighbours, especially with Ukraine and representatives of independent pro-democratic circles in Russia and Belarus. We continued supporting democratic change and civic initiatives in Eastern Partnership countries. We engaged to promote a cohesive foreign policy of the European Union and the inclusion of Polish policy-makers and experts in the European debates addressing key EU issues.

For the second year we supported activities of Belarusian organisations aimed to stimulate civic activism, defend human rights, improve access to independent sources of information; develop independent research and analyses. Several dozen civic organisations and initiatives received a total of PLN 2.95 million (For Belarus).

In the framework of **Open Europe** programme we initiated a number of projects aimed at promoting pro-European and democratic aspirations of the Ukrainian society in the international arena. We organised the participation of Polish observers in an international expert mission during the parliamentary elections in Ukraine as well as several public meetings and conferences with the participation of Ukrainian activists, politicians, journalists and experts to discuss: Euromaidan and its implications, radical movements in Ukraine and Russia, ramifications of the parliamentary elections and challenges faced by Ukraine. Much attention was given to interactions with pro-democratic groups from Russia (we organised two meetings of the PL_RU Club to discuss: the identity of Eastern Europe and culture wars), mobilising governments in Eastern Partnership countries to meet the criteria for implementing visa-free arrangements with the EU, collaboration with Moldova on monitoring the transparency of election campaign financing and prevention of conflict of interest.

In the course of expert meetings organised by the **European Council on Foreign Relations Warsaw Office**, operating at the Foundation, discussions centred on the evolving nature of European leadership and the political and social challenges faced by the European Union in the aftermath of European elections. Other topics included the recent developments in Russia and Ukraine, and in Northern African countries, the future for the Eastern Partnership, the European Neighbourhood Policy and the Common Foreign and Security Policy.

Within the Regional Alcohol and Drug Programme we continued to disseminate the Polish experience and accomplishments in the area of alcohol and drug addiction therapies in Central and Eastern European countries and the former Soviet Republics. We delivered training to Polish immigrants in Western Europe to address alcohol problems and family dysfunction.

In the past year we provided 565 grants and 107 scholarships of a total value of nearly PLN 55.5 million and spent PLN 5.7 million on our own projects.

Citizens for Democracy

The programme, run in cooperation with the Polish Children and Youth Foundation and planned for July 2013-December 2016, is financed from the funds of the Financial Mechanism of the European Economic Area (EEA Grants) provided by Iceland, Liechtenstein and Norway. Apart from Poland, programmes for NGOs financed from EEA Grants operate in 15 European Union countries: Bulgaria, Croatia, Czech Republic, Cyprus, Estonia, Greece, Hungary, Latvia, Lithuania, Malta, Portugal, Romania, Slovakia, Slovenia Spain.

The aim of the programme is to stimulate civic participation in public life, promote democratic values and human rights, develop advocacy and watchdog activity, support groups at risk of exclusion, enhance the capacity of non-governmental organisations, and foster an enabling environment for the development of the third sector. The programme puts special emphasis on such concerns as combating hate speech, hate crimes and extremism, counteracting manifestations of racism, xenophobia, homophobia and anti-Semitism, preventing sexual harassment, gender-based violence and the trafficking of women, and discrimination against the Roma minority, and the promotion of tolerance and intercultural dialogue.

The basic form of operation of the programme is to make grants for projects implemented by non-governmental organisations. Grants are offered in two-stage grant competitions for:

- thematic projects activities undertaken within five thematic areas: civic participation, public scrutiny, combating discrimination, counteracting exclusion, children and youth;
- systemic projects activities designed to strengthen and enhance the quality of functioning of the overall non-governmental sector or its individual 'subsectors'
- bilateral cooperation activities aimed at developing and strengthening cooperation between non-governmental organisations from Poland and Norway, Liechtenstein and Iceland.

Within the programme we organize meetings and workshops for non-governmental organisations, undertake initiatives that aim to counteract hate speech, xenophobia and discrimination, organize events that serve to increase networking with institutions from donor states and experienceshairing among organisations implementing projects supported from EEA Grants in Poland and and 15 other EU countries.

Calls for project proposals

In three rounds of calls for thematic project proposals we received a total of 6,387 projects outlines. In the first round the applications were submitted till September 1, 2013, in the second – till March 1, 2014, in the third – till September 1, 2014. Overall, 1,135 organisations were selected to the second stage of the grant competition and 1,081 of them submitted full project proposals. The first and second round of the call for proposals were resolved in February and August 2014, respectively. The third round will be resolved in January 2015. In the course of two first rounds a total of 354 grants (PLN 81 million) were awarded. Four organizations resigned from grants. 27 smaller organisations that applied for projects of less than PLN 70,000 received additional grants of up to PLN 3,500 to cover the matching funds requirement from the Foundation's own resources.

The call for systemic projects attracted 289 project outlines submitted since October 16, 2013. Out of these 39 organisations were invited to submit full proposals, 9 projects received grants totalling nearly PLN 3.5 million.

Applications for projects involving bilateral cooperation with organisations from Norway, Iceland and Liechtenstein were received on an ongoing basis. In 2014 we received 61 applications for establishing contacts and developing partnership projects in one of the four Programme thematic areas. 29 grants for bilateral cooperation totalling over PLN 624,000 were awarded. Moreover, 12 organisations who had already received grants for thematic projects applied for additional funding for establishing or strengthening cooperation with organisations and institutions from donor states. 5 of them received such grants with a total value of more than PLN 180 000.

Other activities

Meetings and workshops for organisations

As a part of technical assistance we organised 38 meetings and workshops for applicants and grantees. 1,149 NGO representatives from all over Poland used this opportunity to learn about programme requirements and specificities.

We offered four workshop cycles for organizations that applied for grants: three of them focused on three thematic areas in which we received the least number of applications: civic participation, public scrutiny and counteracting discrimination. The fourth cycle addressed planning for institutional capacity building.

We also offered four cycles of meetings to organizations that received grants. The first cycle concentrated on project management, finance and legal issues and information and publicity requirements. Three other addressed practical ways of employing horizontal policies: sustainable development (environmental and social aspects), equal opportunities and good governance.

Counteracting hate speech, xenophobia and discrimination

In March and April, in cooperation with the Opinion Polling Centre and the Prejudice Research Centre, we conducted a national survey of attitudes towards minority groups, sources of prejudice and the level of acceptance of hate speech in traditional and online media and in personal and public life in Poland. The findings of this study were published in Hate Speech. Survey Report and presented in June

20 —

in the Parliament in a public conference "Hate Speech in Poland in 2014: legal and social problem or a media phenomenon?" 240 participants attended the conference including non-governmental leaders, public officials, experts and educators as well as representatives of organizations implementing projects funded by EEA Grants in other European countries and representatives of the Council of Europe, Norwegian government and the EEA Financial Mechanisms Office in Brussels.

The report provided valuable insights into hate speech in Poland. It identified areas where Polish youth and adults are most likely to encounter hate speech (online, interactions with friends) and identified the minorities most likely to be exposed to discrimination (sexual minorities, Roma and Africans). These findings are used by organisations implementing projects combating hate speech among youth and to serve as a reference for developing the message of an awareness campaign targeting school students.

In 2014, we undertook a number of activities aimed to supported a Council of Europe **No Hate Speech Movement** youth campaign. In cooperation with the Polish Children and Youth Foundation we organised two training programmes for youth bloggers in February and August for 20 students of vocational schools in Warsaw and 18 in the Lublin area. The training addressed the basics of journalism and methods of challenging hate speech. Young participants discussed with journalists and public officials, conducted a street poll on hate speech and observe the public space in the city for manifestations of hate speech (posters, ads, murals). The knowledge and observations were then applied by the participants in journalism mini-projects that addressed this topic.

In November, together with the Young Journalists Association "Polis", we organised a meeting of 30 national coordinators of the Council of Europe **No Hate Speech Movement** youth campaign from 27 countries, members of the Executive Group and representatives of the Council of Europe Youth Department Secretariat. The aim of then meeting was to review the campaign process and develop plans for the following year.

In partnership with Centre for Education Development and Anti-discrimination Education Association, we organised a seminar for teachers and education commissioners in December. The *School without Discrimination – Safe School* seminar addressed ways of counteracting discrimination, hate speech, prejudice-motivated violence and offered workshops on methods of engaging with young people. Attendees included 80 teachers, education commissioners and students of pedagogy from all over Poland.

We were also involved in other types of activity. For the June Equality Parade in Warsaw we organized first in the history of parade non-governmental platform. 140 individuals from 17 non-governmental organisations demonstrated with the *Equal Rights – Common Cause* slogan in defence of minority rights.

In September, during the Civic Initiatives Picnic organized in Warsaw in the framework of the Polish Non-governmental Initiatives Forum attended by,600 NGOs from all over Poland we arranged a worhskop space for organisations engaged in counteracting discrimination against minorities and combating hate speech. In the *No-Hate Zone* NGOs organized 'Live Library' with minority representatives, anti-discrimination workshops, quizzes and happenings. Picnic participants were offered an opportunity to produce graffiti and environmentally friendly cloth bags with anti-discriminatory styling, visit the *Borders* photo exhibition about cultural diversity in Poland, take pictures with anti-discriminatory gadgets.

In collaboration with the Media Fund Journalism Society Foundation we organised three highly popular public debates in Warsaw about the language of aggression and hate in media. We invited journalists,

academics and NGO leaders to take part in panel discussions which sought to identify effective ways of responding to online aggression and incitement to violence against specific groups.

In April, together with the Media Fund we organised a contest for an anti-hate speech T-shirt graphic design. Out of,500 submitted designs the jury selected 2 which were used in the production of T-shirts for the Civic Initiatives Picnic and the Equality Parade. One of the winning T-shirt designs was presented at a European foundations' exhibition organised on the 25th anniversary of the European Foundation Centre in Brussels.

We launched a dedicated website mowanienawiści.info [nohatespeech.info] which contains resource materials on hate speech: Polish and European legal acts, project, recommendations and civic initiatives aimed to improve anti-hate legislation, research, analytical reports, educational tools etc.

International Collaboration

In May, during a conference of the European Foundation Centre in Sarajevo w organised a session Discrimination and Prejudice in Europe - Challenges for Grant-makers with the representatives of three European non-governmental organisations: the Polish Society of Anti-Discrimination Law, Slovak Open Society Foundation and the Spanish Calala Women's Fund.

In June, we organised a meeting in Warsaw for operators of EEA Grants NGO programmes in 13 EU Member States. The aim was to share the programme implementation experience and discuss proposed measures to simplify the distribution of funds for non-governmental organisations in the new programming period.

As a part of networking and experience sharing among the NGOs benefiting form the EEA Grants programmes the representatives of Polish organisations attended events organised by operators of EEA Grant programmes in other countries: NGO Fest (9 May) and the Civil Society Forum in Central and Eastern Europe (27–28 November) in Bucharest and the Together against Hate Speech and Hate Crimes conference in Madrid (27 November). Representatives of the Foundation attended meetings for operators of NGO programmes organised by the Financial Mechanism Office in Brussels. A total of 36 individuals from EEA beneficiary countries and 5 individuals from donor states participated in the programme events. Fifteen Polish NGO leaders attended events outside of Poland.

The programme was financed from the EEA Grants (PLN 55,204,043.59), from the Batory Foundation's own resources (PLN 91,708,42) and 1% income tax designation (PLN 46,50).

Equal Opportunities and Donor Advised Funds

The programme goal is to enhance access to education for young people from small towns and impoverished communities. We support non-governmental organisations that run scholarship programmes for school age youth. We also administer funds entrusted to the Foundation by corporate and individuals donors.

Equal Opportunities

Since 2000, we have been supported a network of organisations which: run local scholarship programmes addressed to underprivileged students from secondary schools, particularly from smaller towns or villages; obtain the funds for scholarships from various sources (from local governments, local business, individual donors, public collections, auctions, 1% personal income tax designations, etc.); cooperate with the scholarship beneficiaries and involve them in voluntary work for the benefit of the scholarship programme and the local community.

Scholarship programmes are offered on the basis of principles and regulations developed by the organisations, considering local needs and capabilities. Decisions on scholarship granting depend on good results at school, family income, involvement in the local community, or other achievements. Scholarships in the amount of from PLN 50 to 400 per month are allocated for textbooks, learning aids, payment for dormitories, additional courses, commuting to schools, etc.

Every year, the organisations are offered the possibility of obtaining grants for their scholarship programmes. The organisations that have been participating in the programme for over ten years can obtain a grant in the amount of up to PLN 15,000, the remaining ones – up to PLN 20,000. The grant is provided upon the presentation of the plan and rules of the scholarship programme operation, and when the organization documents funds raised from other donors to match the amount provided by the Foundation. Apart from grants, we offer opportunity to participate in an annual meeting where we discuss the principles and experiences in running scholarship programmes, fundraising, cooperation with local partners, the media, voluntary workers and scholarship beneficiaries. The meetings serve to present the latest research on inequalities and barriers in access to education, discuss the situation of young people, use of modern technologies in youth projects and to review the regulations for non-governmental scholarship programmes.

In 2014, 40 organisations from 13 provinces participated in the programme. They received a total of PLN 547,353 in grants. These funds matched by funds raised from other sources generated scholarships for 881 students in the 2014/2015 school year.

In 2014, the programme was financed from the 1% personal income tax designations (PLN 259,487), revenues from Małgorzata Szejnert Fund (PLN 57,746.94), donations from Agora Foundation (PLN 102,025), Pracuj.pl Group (PLN 80,000), the Gavell Family Fund (PLN46,513), Google Matching Gift Program (PLN 2,565.35) and Informica (PLN 2,500), gifts from corporates and individuals donors (PLN

9,828), from funds provided by the Open Society Foundations (PLN 61,405.76) and from the Foundation's own resources. In addition, Agora S.A. contributed advertising space worth PLN 207,871.98 to support programme promotion.

Donor Advised Funds

Małgorzata Szejnert Fund

The Fund was established in 2002 thanks to a donation made by Małgorzata Szejnert. The revenues generated from the investment of its assets has been allocated annually for assistance to children and youth.

In 2014 the Fund financed **5** grants in the amount of PLN 49,500 to organisations participating in the Equal Opportunities programme.

Gavell Family Fund

The Fund was established in 2010 from annual donation by the Quo Vadis Foundation of the Gavell Family from the USA. The Fund's resources are used as scholarships for underprivileged students and smaller towns or villages in the Świętokrzyskie Province.

In 2014 the Fund financed 3 grants in the amount of PLN 46,513 to organisations participating in the Equal Opportunities programme.

Staszek Jonczyk "Sing" Fund

The Fund was established in 2011 by the family of tragically deceased Staszek Jonczyk, an artist of the Gregorianum Choir passionate about choral music, with an aim to help the development of the amateur choir movement, and principally activities related to voice perfecting and improvement of vocal skills of choir members. It is supported by donations from private individuals as well as by 1% personal income tax designations.

In 2014 the Fund financed 5 grants for amateur choirs in the amount of PLN 18,000.

Beata Pawlak Fund

The Fund was established from a donation bequeathed by the deceased Beata Pawlak, Polish journalist and writer killed in a terrorist attack on Bali in 2002. As requested by the donor, the Fund awards an annual prize to an author of an article or publication on foreign cultures, religions and civilizations. The winners of the twelveth edition of the Beata Pawlak Award were Mateusz Janiszewski for the book House on the river Loes (Wydawnictwo Czarne, Wołowiec 2014) and Adam Lach for the book Stigma (editor: Adam Lach, 2014). The award ceremony was accompanied by a debate (see the **Batory Foundation Debates**).

The winners received two equivalent awards in the total amount of PLN 14,000.

Iwona Winiarska-Feleszko Fund

The Fund was established in 2008 by friends and family of a tragically deceased lawyer, Iwona Winiarska-Feleszko with an aim to provide grants for scholarships for students from low-income families and small communities who enroll at Warsaw-based state universities. It is supported by donations from private individuals as well as by 1% personal income tax designations.

In 2014, the Fund disbursed 8 scholarships of a total value of PLN 38,500: 5 scholarships of PLN 500 per month for first year students of a total vaue PLN 25,000 and 3 scholarships of PLN for second year students totalling PLN 13,500.

Janina and Tomasz Maczuga Fund

The Fund was established in 2012 by Janina and Tomasz Maczuga from a sale of books and prints collection to support young people from low-income families who enroll at Polish state institutions of higher learning for bachelor's or master's studies. The Fund is designated for scholarships for graduates of three upper secondary schools from donors' family towns of Wadowice and Nowy Sącz.

In 2014, Fund awarded 4 annual scholarships of PLN 500 per month for first year students of a total value of PLN 20,000.

J. and J. Putka "Spread Your Wings" Fund

The Fund was established in 2011 by the Putka family. The Fund benefits from donations and 1% personal income tax designations from the Putka family members and people supporting the Fund's aim. The Fund's assets are allocated to scholarships for young people from low-income families who without scholarship support would not decide to study at institutions of higher learning. The Fund offers one time grants to secondary school graduates to cover the costs associated with the process of enrolment at the university; scholarships for the first year of bachelor's or master's studies at Polish state institutions of higher learning, and scholarships for continuation of studies in the 2nd and 3rd year.

In 2014, the Fund granted 25 scholarshipst from PLN 105 to PLN 475 to cover enrolment costs totalling PLN 5,694, 15 scholarships of PLN 630 per month for first year students totalling PLN 94,500 12 scholarships of PLN 350–410 per month for 2nd year students totalling PLN 41,040 and 4 scholarships of PLN 350-380 per month for 3d year students totalling PLN 13,410. In total the Fund awared scholarships in the amount of PLN 154,644.

Karol Uryga-Nawarowski Fund

The Fund was established in,2008 with an annual donation by the US-based Karol Uryga-Nawarowski Foundation to help organizations that support and provide therapy to children and youth suffering from the Fetal Alcohol Syndrome (FAS), as well as provide training, support and professional assistance to their families, therapists and teachers.

In 2014, the Fund financed 2 grants in the amount of PLN 42,000.

For Belarus

The aim of the programme is to stimulate the development of civil society and support democratic changes in Belarus. We make grants to Belarusian non-governmental organisations which undertake initiatives aimed to: stimulate civic engagement and developing self-government and self-organisation (also through educational and cultural activity, and youth initiatives); defend human rights, provide legal assistance, counteract discrimination and promote tolerance; enhance access to reliable information and develop traditional and social media; conduct independent research and analyses.

Grants

Majority of the projects supported within the programme focused on **stimulating civic activity**: engaging residents in initiatives for the benefit of local communities including activities aimed to improve quality of life and cooperation between residents and local government (i.a. public consultations, improving quality of public transport, promotion of biking); as well as education activities, enhancing formal education provision, building national identity and protecting historical heritage (e.g. interactive Belarusian courses for adults, building archives of spoken history).

There was a fairly large group of initiatives from **the area of human rights protection**. We supported projects aimed at introducing changes in the functioning of law, monitoring of the respect and protection of civic rights, as well as activities aimed at building tolerance and preventing discrimination.

We pursued the goal of **improving citizens' access to information** by making grants to help the publication of independent journals, online portals and e-zines, raise and strengthen skills of journalists and media professionals and for activities aimed to defend the freedom of speech.

We supported the work of **independent research centres** which monitor the social, economic and political situation in Belarus.

We launched efforts to develop the **capacity of non-governmental organisations** in Belarus by helping develop knowledge and skills of Third Sector activists in such areas as management, team-building, developing strategies and operational plans, advocacy, building relations with stakeholders, media and fundraising.

Other activities

On June 10–11, the Batory Foundation and the Eastern European Democracy Centre organised in Warsaw Belarus International Implementers Meeting of donors and organizations supporting civil society in Belarus and a Forum of Belarusian Non-governmental Organisations and Initiatives which attracted representatives of 76 Belarusian non-governmental organisations. On the eve of the Forum (June 9), we organised jointly with the ECFR Warsaw Office a public debate "Ukraine in the Belarusian Lens". The impact of the developments in Ukraine on the neighbouring Belarus was discussed by Ryhor Astapen (portal ideaBY.org, Saligorsk), Anaïs Marin (independent analyst, France), Wojciech Konończuk (Eastern Studies Centre) and Serge Naurodski (President of CASE Belarus).

On July 10, together with the Helsinki Human Rights Foundation we organised a debate and a press conference with Ales Byalatski, a human rights activist jailed in Belarus. As part of the Days of Solidarity with Civil Society in Belarus (28 July–4 August), we organised the Belarus Press Photo exhibition in Krakowskie Przedmieście Street in Warsaw which documented the contemporary realities of Belarus as well as a debate on the impact of independent cultural initiatives on the development of civil society in one of Warsaw's cafes. The debate was attended by Polish and Belarusian activists from non-governmental organisations engaged in cultural activities.

Other Grants

As Poland celebrated its 25th anniversary of democratic transition in 2014, we engaged in facilitating, coordinating and promoting civic celebrations of this special day for democracy. These activities were implemented in the framework of an informal coalition of non-governmental organisations Together 89, formed in 2009. The coalition integrated under one logo a variety of national and local anniversary initiatives of Polish non-governmental organisations, schools, libraries and informal groups. The Foundation supported several anniversary celebration initiatives, including the establishment of the Tadeusz Mazowiecki faculty at Warsaw Univeristy, organisation of the Jacek Kuroń festival and the operation of the Together 89 Secretariat which co-ordinated the work of the coalition.

25 years of freedom competition

The aim of the competition was to support the civic celebrations of the 25th anniversary of democratic transition in Poland: activities commemorating Poland's first democratic election of 1989, recalling historic events and individuals who were behind the democratic change both at the national level and in local communities, as well as initiatives reflecting upon the past 25 years and demonstrating the changes that had been achieved since 1989. We promoted initiatives undertaken outside of big cities, those which bridged different generations and communities, highlighted the role of women in the transformation process, as well as initiatives implemented in partnerships with other organisations and public institutions such as community centres, libraries, schools and media.

In the competition we offered grants of up to PLN 3,000. Out of 333 applications submitted in the competition 50 totaling PLN 131,600 were selected for funding. The majority of them (39) were preprared by non-governmental organisations; 10 were submitted by informal groups operating in schools, libraries and community centres; one project was proposed by a social cooperative. The celebration event took place in 13 provinces and involved 170,000 individuals.

Batory Foundation Debates

Batory Foundation Debates are an attempt at establishing an independent meeting and discussion forum for politicians, professionals, public intellectuals and journalists. We have long organized conferences and discussions on changes taking place in our country, in Europe and in the world, on Polish and EU foreign policy and international affairs. Our goal has been to foster public debate on issues important to the future of our country and region.

In 2014, our debates concentrated on the central issues of Poland's internal policy and the quality of public life, including the political transition over the past 25 years.

A philosopher who changed space 25 February, 2014

Your Vote, Your Choice

The program's goal is to increase public interest in local affairs and to encourage civic participation in public life, including an informed and responsible participation in local and parliamentary elections. In order to achieve these goals we organize social and awareness raising campaigns. We work with the local organizations assisting them in undertaking activities that spur civic participation, foster dialogue between constituents and their representatives in local governments and integrate local communities around local problems solving. We carry out activities aimed to increase voter turnout and improve the quality of elections.

Your Vote, Your Choice project

Since 2006 we have been organizing nationwide action aimed at initiating and promoting cooperation between residents and local authorities in solving local problems and to reinforce a sense of joint responsibility for the election promises and decisions made on the election day. The action is open to any organization or informal group as well as libraries, schools, and other institutions which register at the portal www.maszglos.pl and commit to engage in projects aimed at increasing public participation, fostering dialogue between community members and their representatives in local government and integrating local communities around local problem solving. All registered participants are offered substantive support, which includes a cycle of workshops, individual consultations and expert advice, instruction and promotional materials as well as information and experience sharing through the project's website.

In 2014 the participants were offered to follow one of three scenarios of activities that would help engage residents in the decision making about their communities: perform local community needs assessments, develop public consultation mechanisms, introduce participatory budgeting at the local level. The fourth scenario proposed that year was linked to the autumn local elections: it was to undertake initiatives aimed to mobilise the citizens to go to the polls and make informed choices. The specific tasks to be completed in the election period included: an evaluation of the four-year term of office in local governments, collect information about the candidates and share it with citizens, monitor the capacity of municipalities to organise the elections in a citizen-friendly manner and, additionally, run local voter turnout promotion campaigns. Based on the identified local problems, the participants organised pre-election debates where they asked candidates about their plans with

respect to key local issues. Activities were implemented in partnership with local governments, electoral committees and candidates.

In 2014, the campaign was implemented in partnership with Opus Center for Promotion and Development of Civic Initiatives, Sustainable Development Workshop, Civic Network – Watchdog Poland, Association 61 and School of Leaders Association, Our partners supervised implementation of particular scenarios and advised the participants on how to engage residents and encourage local authorities to cooperation.

We facilitated contacts with local authorities and media, helped the participants in promotion activities (providing them with posters and other informational and promotional materials). We consulted them on the scope of local authorities' powers and legal regulations (including publication and dissemination of the Charter of Residents Rights, Civic Toolbox, and a leaflets: How to work with the media, How to access public information, How to talk to local residents, How to carry out a local needs assessment, and How to organise debates). We also organised a three-day workshop to help develop skills essential for working with local communities which attended by 93 individuals.

This year over,600 participants: organizations, informal groups, local media, cultural centers, libraries and other institutions from,400 localities joined the project. 12 participants who were most effective in facilitating cooperation of residents and local authorities competed for the **Super Local Government 2014** award, held under the honorary patronage of the President of Poland.

Voter turnout campaigns

European campaign

Two nationwide voter turnout campaigns – before the European Parliament 25 May and the November 16 local government elections – complemented and reinforced the activities carried out locally by non-governmental organizations taking part in the Your Vote, Your Choice project. These campaigns, like those in previous years, were conducted within a broad coalition of NGOs which in 2014 consisted of: Center for Citizenship Education, European Forum at the Warsaw University European Center, Civil Development Forum, Project:Poland Foundation, Information Society Development Foundation, Institute of Public Affairs, Chamber of News Publishers, Polish Confederation Lewiatan, Polish Robert Schuman Foundation, Association of Marketing Communications SAR, Economic Chamber of Outdoor Advertising, Friends of Integration Association, School of Leaders Association.

The campaign before the European Parliament election mainly targeted youth (voter turnout is the lowest in this group in all types of elections) and those individuals who tend to go to the polls in domestic elections but do not vote in European ones. The strategy and materials for this campaign, ran under slogan Vote and Elect a MEP who Thinks like You, were developed by a professional advertising agency Walk Creative. The coalition was supported by media house ZenithOptiMedia.

The materials for the campaign included: radio and television spot, press ads, banners and an online application www.niedlaantyposla.pl. A dedicated website www.glosuj.org.pl and a dedicated Facebook fanpage www.facebook.com/maszglos were launched. The spots were aired on national radio and television channels, in local stations and in the Multikino and New Age Media cinemas across Poland. Press ads were published in many titles including *Angora*, *Polityka*, *Tygodnik Powszechny*, *Przegląd*, *Kropka TV*, *To&Owo*, *Tele Świat*, *Tele Tydzień*, *Super Express*, *Nasze Miasto* and in journals published by Agora S.A. The campaign poster was displayed in 34 shopping centres across Poland and the advertising

spot ran on 400 on-board display monitors in 180 public buses in Wrocław. Campain materials were aired pro bono or at reduced prices. Online banners were hosted free of charge by major portal: gazeta.pl, wyborcza.pl, onet.pl, allegro.pl and youtube.com.

A number of celebrity figures supported our promotional efforts, including: Agnieszka Grochowska, Maciej Orłoś, Robert Makłowicz, Prof. Ewa Łętowska, Dr Anna Materska-Sosnowska, Dr Jarosław Flis, Janina Ochojska, Jan Wróbel. They featured in TV, radio and online spots which encouraged citizens to go to the polls.

The media campaign was accompanied by local activities implemented by the participants of the Your Vote, Your Choice action and the Youth Vote project ran by Center for Citizenship Education.

Beside the campaign targeting voters in Poland, the School of Leaders Association carried a campaign to encourage Polish voters who are residents of Ireland and the United Kingdom to cast a vote. The campaign was run under a slogan You Are at Home. Vote! It was conducted in cooperation with local Polish community leaders. Nearly 50 organisations and over 100 Saturday schools and parishes, and,400 merchants were effectively engaged in this campaign.

Apart from activities aimed to encourage voters to go to the polls, the campaign offered information and education about election procedures such as voting outside of one's place of residence, voting by proxy available to elderly or disabled individuals, and the powers of the European Parliament. We developed a wide variety of supporting materials such as infographics posted on the coalition website: www.maszglos.pl and www.glosuj.pl. Our materials were used by Super Express, Polska Presse, Gazeta Wyborcza and regional media in their articles about election procedures.

Local election campaign

Before the November 16 local elections we launched a national voter turnout campaign. The campaign under a slogan Each reason matters! informed people about the powers of local governments and encouraged them to cast an informed vote, i.e. based on the knowledge of candidates' views, track record and electoral programme. The strategy and supporting materials for this campaign were developed by 2012 Agency. MEC Active Engagement media agency helped in distribution of campaign materials in the media.

The materials for the campaign included: radio and television spots, press and online ads, posters (17,000) and leaflets (9,000). Our spots were aired in national and local TV and radio stations including TVP 1, TVP 2, TVP Regional, TVP Info, TVP Historia, Magnes.tv, TV Chopin, Telewizja Bogatynia, itvpiaseczno.pl, Polskie Radio Channel 1, RDC Polskie Radio, Radio Koszalin, Radio Lublin, Radio Opole, Radio Rzeszów, Nasze.fm Sieradz, Radio 7, Polskie Rozgłośnie Akademickie, Radio Centrum, Radio Żak, Radio Akadera, Radio Afera. Online banners were hosted by major portals: gazeta.pl, onet.pl, interia.pl, infor.pl, wp.pl, o2.pl. Press ads appeared in *Angora, Wprost, Tygodnik Powszechny, Przegląd, Tygodnik Kępiński, Nowy Tydzień, Extra Kielce, Wiadomości Powiatu Gliwickiego, Gazeta Sołecka* and dailies and magazines published by Agora S.A. The campaign spot was displayed in 31 shopping centres across Poland and on on-board display monitors in public transport in Warsaw and the Łódź province. We carried out promotional activities in social media including www.facebook.com/maszglos profile. The campaign was joined by over 600 organisations and informal groups, including 200 schools which organised debates with local political candidates and carried out local mobilisation campaigns using our posters and leaflets.

During the campaign we carried out intensive informational activities. On the campaign website www.maszglos.pl as well as on the coalition website www.glosuj.org.pl there were guides for both candidates and voters, the experts provided online consultations and advice on the election law. In cooperation with journalists, we provided information in the media about the election calendar, the responsibilities of various levels of local government, the procedures for candidacy and voting (including registration and proxy voting by the disabled and elderly), we advice how to get to know the electoral platform of the candidates. Coalition representatives were invited to the media to talk about the elections and local government powers (120 radio and TV appearances). The activities underataken in the campaign were extensively reported in print and electronic media (ca. 1,200 publications).

Advocacy efforts

In 2014 our advocacy work focused on two areas in 2014: raising democratic standards in local government, i.e. greater inclusion of citizens in local decision-making in municipalities, and making voting procedures easier for the electorate.

We organised a seminar attended by experts, non-governmental leaders and representatives of the Ministry of Administration and Digitisation to discuss the roll-out of participatory budgeting in cities. We published a report presenting the experience related to the introduction of participatory budgeting in dozens of communities highlighting difficulties encountered in the course of its implementation and proposing some policy solutions. The report was distributed to media, policy-makers, experts and non-governmental organisations.

After the local elections, we organised a seminar for civil society organisations and civic groups to discuss the need for change in the local government legislation in Poland. The discussion centred on the role of local council members and ways to ensure more influence on local policy by the residents. The participants decided to write up a list of demands to be submitted to the Parliament's Extraordinary Committee for amending local government legislation.

Under the supervision of Prof. Andrzej Rychard (Institute of Philosophy and Sociology, Polish Academy of Sciences) we organised a cycle of seminars for policy-makers and experts to discuss possible ways of improving the quality of political party system in Poland. During four meetings the participants explored means of improving political party communications with the public, preventing 'oligarchisation' and authoritarian leadership styles, raising quality of party programmes and improving the transparency of party financing. A report containing the summary of the debates and proposed policies to improve the quality of political parties is to be published in 2015 and will be used as a basis for further advocacy work.

In 2014, the programme was financed from funds provided by the Open Society Foundations (PLN 2,044,118.85 including a grant of PLN 1,000,360.25 from the Open Society Initiative for Europe programme), from a gift by an individual donor (PLN 2,500) and from the Foundation's own resources.

In-kind contributions in the form of free advertising space were made by: Agora S.A. (contribution of PLN 454,949 for the voter turnout campaigns) and PAP SA (contribution of PLN 4,500 for the promotion of Your Vote, Your Choice action).

Public Integrity

The goal of the programme is to increase transparency and integrity in public life and to promote open, accountable governance. Within the programme we undertake activities which aim to ensure the transparency of the legislative process and open it up to the voice of citizens, to reduce the risks of corruption, nepotism and cronyism linked to the presence of conflicts of interest in public life and to strengthen the role and legal protection of whistleblowers. We monitor and analyze processes and events which affect the integrity of public life. We present proposals and recommendations aiming at improving the standards of public life and curbing corruption. We take measures to develop, disseminate and implement solutions which comply with the standard of good governance and accountable government.

The programme is a continuation of the Anti-Corruption programme launched in 2000, which led to a number of significant institutional and legal changes.

Civic Legislative Forum

For several past years we have been undertaking activities aimed at introducing legal solutions that will increase transparency of legislative processes. We have been carrying out advocacy efforts within the framework of the Civic Legislative Forum set up in 2009 with an aim to bring together people participating in the legislative process or monitoring it. In 2011 the Civic Legislative Forum, supported by experts in constitutional law, initiated a discussion on the merits of creating new legal frameworks that would reorganize the law-making process, strengthening the role of public consultations in this process and implementing solutions increasing its transparency.

In 2014, members of the Forum started to observe the process of drafting selected government acts, verifying to what extent the new Work Regulations of the Council of Ministers led to enhancing the standards of public consultations. Conclusions from the observations are presented on quarterly basis during press conferences and in a communication sent to the Chancellery of the Prime Minister, Government Legislation Office, Chancellery of the President, ministries, selected parliamentary committees and to the media.

The Forum intervented also at the Ministry of Finance in connection with bad consultation practices, which, contrary to the new Work Regulations of the Council of Ministers, envisaged 10 days for consultations of the draft Tax Administration Act, at the same time announcing that lack of comments or remarks within the said deadline would be considered as approval of the draft.

In 2014, members of the Forum gave their opinion on the Guidelines on impact assessment and public consultations in governmental legislative process prepared by the Ministry of Economy, and participated in a consultation meeting organised by the ministry. Furthermore, the Forum continued monitoring the process of the implementation of the Better Regulations 2015 strategy, which included the Code of Public Consulations.

Analisysis of public consultations in practice

Public consultations are an important component of the modern model of legislature. They open the legislative process to public input, make it more transparent, improve the chances of the new legislation being more readily understood and accepted by society. Consultations are also an important part of the Regulatory Impact Assessment (RIA) procedure which is aimed to develop the substantive basis for the legislative proposals. Sound consultations conducted as part of the RIA process ensure that such new legislation is designed to best meet the goals and objectives of the lawmakers without generating detrimental social, economic or political impacts. By involving a variety of stakeholders with different backgrounds and expertise in the RIA process legislators can get an important source of knowledge about the practical implications of the proposed law.

In 2014, we completed a 20-month-long monitoring of the effects of changes related to public consultations and RIAs that were introduced by the Government in late 2011. The aim of the analysis was to test the impact of the 2011 amendments on the quality of legislation and the adequacy of the public consultations process. We examined 110 draft bills which were processed by the government in 2012, together with related documentation, and analyzed in-depth 6 case studies of selected bills. Conclusions from the study and recommendations were discussed during an expert panel participated by members of the Civic Legislative Forum, government representatives, Legislative Bureau of the Polish Parliament, Office of the Human Rights Defender, trade unions, law firms, the academia and individuals from non-governmental organisations actively participating in consultation processes.

The study revealed that whereas some positive changes occurred in the process of conducting public consultations (e.g. almost 93% drafts of government acts proceeded in 2012 were subjected to more or less extensive process of consultation), the process of preparing Regulatory Impact Assessments is undoubtedly a weakness of the legislative process (e.g. in 3/4 of the analyzed drafts no attempt was made to introduce quantitative measurements of target objectives). The study report recommends to undertake a number of actions, above all of organizational nature or related to good practices, such as unifying the practice of legislative work in all ministries, starting the legislative work from preparation of the guidelines or strengthening the know-how of analytical departments in ministries. The main postulate emphasises the need of statutory regulation of the legislative process.

Theses from the study report were presented on 2 December at a public conference attended by 150 participants: experts, lawyers, NGO activist, public administration officials, representatives of the media. Government representatives: deputy minister of economy Mariusz Haładyj and vice-president of the Government Legislation Office, Piotr Gryska commented on the report findings. A broader, European background of the legislative process was outlined by Terje Dyrstad from the Norwegian Ministry of Government Administration and Reform and Michal Narożny, political analyst in the Secretariat-General of the European Commission.

Copies of the report were distributed among conference participants and sent to the Chancellery of the President, the Prime Minister and the Parliament. Results of the study were also published in the

form of an e-book. Digital version of the report was published on the website of the Constitutional Court.

Both the conference as well as the report itself met with considerable interest. Over 40 coverages of the topic were presented by the media, including an article by Mariusz Haładyj and Piotr Gryska in the *Rzeczpospolita* daily describing activities of the government aimed at correcting the errors and short-comings presented in the report. Employees of the Government Legislation Centre and the Ministry of Justice asked for access to working materials that were the basis for assessment of drafts authored by them. After further analyses, the materials are to be used to improve the legislative process in the aforementioned institutions.

Personal unions in local governments

The aim of the project planned for 2013–2014 was to investigate the scale and character of personal links at the local level and to determine whether and how the fact that local council members play other socio-economic roles (in public administrations, public and private business and in non-governmental organisations) affects the economic development of local community, the political situation and civic activity at the local level. On the basis of publicly available sources, we analysed nearly 9000 financial declarations by councillors from all levels of local government and data pertaining to them from the National Electoral Commission and the National Court Register. Connections and social and professional roles of the councillors were also analysed in 11 case studies in selected local government units.

Results of the project were presented during a conference on 22 October, 2014, right before the local elections. The study showed that the most numerous group among councillors comprises of officials and employees of units reporting to local authorities. On the county level (second level of administrative division of Poland), they account for over half of all councillors, and the share of officials from other local government units in county councils exceeds 40%. Moreover, the study showed that share of councillors stemming from local public officials and other individuals dependent on local government executive bodies is strongly linked to their party allegiance. Such composition of local councils disrupts the balance in local authorities and significantly limits their capacity to control the executive bodies and subordinated administration.

The study report met with considerable interest from the media, it was presented and discussed in scores of press articles, radio and TV programmes. Comprehensive analyses and interviews concerning the report were published by the *Gazeta Wyborcza* daily and *Tygodnik Powszechny* weekly. The Chancellery of the President of Poland as well as MPs refered to the report in their public statements. Results of the project are used in the ongoing public discussion on the need of local government reform and in the recommendations prepared by non-governmental organisations concerning strengthening the role of councillors and opening up local governments to the voice of the residents

Monitoring of conflict of interest policies

The objective of this international project planned for 2013–2015 and implemented in collaboration with organisations from three Eastern Partnership countries (Armenia, Moldova and Ukraine) is to improve state efficiency and strengthen the role of citizens in their efforts designed to reduce conflicts of interest in government. Participants in the project, which is funded by the European Commission, include the Moldova branch of Transparency International (project leader), Eurasia Partnership

Foundation, Transparency International Anti-Corruption Centre from Armenia and the Ukrainian Institute for Public Policy and TORO Creative Union from Ukraine.

In 2014, in cooperation with the Department of Civil Service, the National School of Public Administration and the Ministry of the Interior, we carried out a study of internal policies concerning conflict of interest in the Chancellery of the Prime Minister and 18 ministries. The study revealed that most of the ministries lack a coherent internal policy preventing conflict of interest and that many of the instruments that could be used in administration to limit the risk related to conflict of interest are either not used at all (e.g. provisions of the lobbying act), or not applied consistently (e.g. special "ethical order" introduced in the end of 2011, or the management control system). A report from the monitoring was presented on 30 October 2014 during a conference participated i.a. by the head of the Civil Service and the Director of the National School of Public Administration. Information about the study results was presented in several publications, as well as radio and TV programmes. Further activities will be conducted in 2015.

Support and legal protection of whistleblowers

Since 2009, we have been working to strengthen the legal protection of whistleblowers, i.e. persons who, acting in good faith and in the interest of the public good, reveal irregularities or unethical behaviour in their workplace or profession and thus run the risk of being mobbed, losing their job or finding themselves on the margins of their profession. In previous years our efforts consisted mainly of monitoring the legal situation of whistleblowers and advocating stronger legal protection for such persons as well as in drawing the attention of important groups and circles whose voice is meaningful (trade unions, legal professionals and employers) to the problems of whistleblowers. Currently, we are concentrating on advocacy aimed at introducing regulations ensuring better protection of whistleblowers in Poland as well as information and educational activities leading to a change of their social perception.

In 2014, we prepared a series of four short **educational films** on whistleblowers, showing how important signalling threats and irregularities by employees is to the public and economic interest, as well as presenting the consequences and cost resulting from social disapproval and lack of legal protection of such actions. The films are disseminated in social media: FB, You Tube and on blogs dealing with transparency and quality of public life as well as through the channels of the Central Anti-Corruption Bureau.

Our advocacy efforts to regulate the legal status of whistleblowers and the rules of signalling irregularirties in workplace included presentation of these problems at the workshops for the staff of Customs Service, a seminar for entrepreneurs and representatives of the public sector organised by PwC and at a conference of the Polish Association of Occupational Safety and Health Services Workers in Olsztyn. The need of statutory protection of whistleblowers was presented in an article in Dialogue magazine covering activities of the Trilateral Commission and in several interviews in the branch an popular media.

Within the framework of activities aimed at improving the situation of whistleblowers, we held talks with representatives of the Ministry of Labour and Social Policy concerning inclusion of the problems related to protection of whistleblowers into the government's anti-corruption strategy. This postulate

was included in our shadow report to the government's report on the implementation of the United Nations Convention against Corruption.

In our advocacy work we were supported by an informal group of whistleblowing experts, consisting of persons who participated in the series of seminars on whistleblowers that we organised in 2013: lawyers, trade unionists, labour inspectors, representatives of social organizations dealing with the transparency of public life, responsible business and companies interested in promoting whistleblowing. In the aftermath of the catastrpophe in the Myślenice-Wesoła Coal Mine on 27 November, 2014, the Group sent an open letter to the authorities, pointing out that better protection of whistleblowers could lead to limiting the risk of similar events occurring in the future. One of the effects of our work were consultations on the need to regulate the issue of whistleblowers undertaken by the Ministry of Labour and Social Policy with employers' organizations and trade unions. In December, we presented the position in this respect during a meeting of the Team for Labour Law of the Tripartite Commission.

Open Government Coalition

The Open Government Coalition was created in May 2012 by Polish non-governmental organisations that work for transparency, accessibility and openness of public institutions. Apart from the Stefan Batory Foundation, the Coalition includes: Centre for Civic Education, ePF (e-State Foundation), Civil Development Forum Foundation, Panoptykon Foundation, Project: Poland Foundation, Helsinki Foundation for Human Rights, Civic Network – Watchdog Poland, Unit for Social Innovation and Research – Shipyard, Association 61, Klon/Jawor Association, Foundation of Social Communication. The goal of the Coalition is to implement the good governance standards promoted by the Open Government Partnership (OGP) – an international initiative established in September 2011 by the governments of eight countries (including Brazil, the US and the UK). In 2013 OGP was joined by 63 states that pledged to respect and promote the rules of transparency, openness and accountability in governance and undertake concrete steps towards increasing the participation of the society in monitoring and evaluating the activities of the government. Poland is one of the 2 new EU member states that have not joined this initiative.

The Open Government Coalition started its activities by trying to urge the Polish government to join the international initiative. However, despite initial announcements, the government did not join the Open Government Partnership declaring that the objectives and requirements of this initiative will be realised in the framework of the Efficient State 2020 strategy adopted in February 2013. In this situation the Coalition decided to monitor the implementation of the strategy provisions in four areas of key importance from the point of view of open government's principles: access to public information, the openness of public data, anti-corruption policies and the openness of decision-making processes. The results of the monitoring were comprised in the report Waiting for Open Government and presented at a public conference held on 18 December 2013.

In 2014, authors of the report presented its theses during a meeting of the Parliamentary Committee for Innovation and New Technologies. Representatives of the Coalition took part in public consultations organised by the Ministry of Administration and Digitization concerning draft of the act on re-use of public sector information, and published two policy briefs concerning access to public information and opening public data.

Civic Observatory

From 2013 we closely monitor initiatives and events important from the point of view of the integrity of public life. On the basis of the monitoring we produce reports and in-depth analyses of events, initiatives and bills etc. which are relevant to transparency, accountability and integrity of public life. Through the Observatory we want to reach out to the public, to pro-actively affect public debate and increase awareness of such issues as good governance, transparency, problems of corruption and anti-corruption policies.

In 2014, we published 10 articles and press releases, i.a. relating to the organisation of public consultations held by ministries, development of the government anti-corruption programme, situation of whistleblowers, or the need of reforms of the local government. Texts prepared by the Observatory were published i.a. in *Rzeczpospolita* and *Gazeta Wyborcza* dailies and the ngo.pl portal. Analysis of the problems of public consultations was presented in the "INFOS" magazine published by the Bureau of Research of the Chancellery of the Seym, which is distributed among all deputies.

In 2014, the programme was financed from funds provided by the Open Society Foundations PLN 160,474), the grants from the European Commission via the Moldavian branch of Transparency International (PLN 177,037), donations of private companies (PLN 4,550), 1% income tax designations (PLN 255.70) and from the Foundation's own resources.

Open Europe

The goal of the programme is to promote an active and friendly Polish and European Union policy towards our Eastern neighbors and to support democratic processes and pro-European trends in Eastern Europe. We work to bring the Eastern Partnership societies closer to the European Union and to accelerate the process of liberalization of the visa regime. We conduct our activities in cooperation with organisations and institutions from the EU and Eastern Partnership countries. We carry out our activities in cooperation with organisations and institutions from the EU, Eastern Partnership countries and Russia.

A friendly EU border

In this project, which has been run since 2002, we undertake actions aimed at gradual liberalisation of the EU's visa policy and abolition of visas for Eastern Partnership countries and Russia, as well as limiting the burden related to crossing external borders of the EU.

We seek i.a. implementation of the commitments included in visa facilitation agreements and in the Visa Code, adoption of action plans for visa liberalisation, preparation of special solutions for Belarus, which does not have a visa facilitation agreement. We try to present arguments in favour of visa policy liberalisation and dispel fears and concerns among the member states concerning the perspectives of visa-free movement.

In our efforts to accelerate the process of lifting the visa regime and improve the quality of service for travelers at the eastern border of the EU, we collaborate with organizations and institutions from the EU and from Eastern European countries. We also cooperate within the Visa-Free-Europe Coalition launched on our initiative in 2010, which brings together 50 organizations and institutions from the EU states and Eastern European countries. We raise the problem of visa liberalization in the framework of the Civil Society EaP Forum and Russian Civil Society Forum where we coordinate the work of the visa subgroup.

In 2014, we continued the monitoring of progress in visa dialogue between the EU, the Eastern Partnership states and Russia. On one side, we verified the progress made in implementing the necessary reform for visa liberalisation among our eastern neighbours, on the other, EU compliance with commitments to the liberalisation of visa policy.

In cooperation with observers from EaP countries we conducted regular compliance assessments of the legislation in those countries with reference to the requirements stipulated in Action Plans or other bilateral documents. The results of this research were presented in regularly updated the Eastern Partnership Visa Liberalisation Index, an interactive internet tool (monitoring.visa-free-europe.eu) showing the progress of the EaP states towards visa liberalization. We disseminated information about progress in the implementation of reforms and visa dialogue via electronic newsletter, distributed every quarter to over 10,000 recipients (decision-makers, ministries of foreign and internal affairs, agencies and government institutions, public administration, academic and analytical centres, media in the EU and EaP countries).

We used the results of the monitoring illustrated by the Index in the information, promotion and advocacy efforts carried out in the EU and the EaP countries.

On 9–10 April during the Eastern Forum in Berlin, organised by the German Committee on Eastern European Economic Relations, we presented the activities of Visa-Free-Europe Coalition and the latest results of the Visa Liberalisation Index. On 23–26 May in Yerevan, we participated in a workshop on visa rights and obligations organised for journalists of national Armenian media by the Analytical Centre on Globalisation and Regional Cooperation.

In May, in cooperation with the Ukrainian member of the Coalition, the Europe without Barriers, we prepared a report about Kyiv's progress on the path to visa liberalisation entitled A Second Chance for Ukraine. We included in it recommendations concerning specific actions to be undertaken by Ukraine's new authorities in order to meet the criteria set by the European Union. Theses of the report were presented: in Kyiv – at a conference organised together with Europe without Barriers, participated by representatives of Ukrainian authorities, non-governmental organisations and experts (4 June); in Warsaw – at a meeting in the Foundation's seat with representatives of the Ministry of Foreign Affairs and the Ministry of Justice (10 June); in Brussels – during a debate in the seat of the Open Society European Policy Institute participated by representatives of non-governmental organisations and think tanks from the EU and Eastern Partnership countries (16 June) and at a meeting of the Working Group 1 Democracy, Human Rights, Good Governance and Stability of the Eastern Partnership Civil Society Forum (17 June).

In September, together with the Open Society Foundation from Georgia, we prepared a study entitled Georgia's Time, summarising the country's progress towards a visa-free regime with the European Union. We presented the report in Tbilisi – during a public debate on visa liberalisation between the EU and Georgia, organised in cooperation with the Open Society Foundation and the Caucasus Institute for Peace, Democracy and Development, participated by Georgian journalists, government representatives and non-governmental organisations activists (23 October), and in Warsaw – at an experts' seminar with Polish experts on Eastern affairs, journalists and representatives of the Ministry of Foreign Affairs (5 December).

Information concerning changes in the EU visa policy and progress in the visa dialogue between the EU and EaP countries and the EU and Russia was sent by us in a monthly digital newsletter to approx. 1500 recipients in the EU and Eastern Partnership countries. At the Coalition's website (on average 8000 visitors per month) and the Coalition's FB profile (3500 likes), we presented information and analyses concerning the EU–EaP and EU–Russia visa dialogue.

We took part in the works of the EaP Civil Society Forum encompassing over 200 organisations from the EU member states and EaP countries, and in the UE-Russia Civil Society Forum, participated by 140 organisations from Russia and the EU member states. In the latter, we coordinated the works of the visa subgroup.

At the turn of March and April, we participated in a seminar organised in Moscow by the Delegation of the EU to Russia for organisations that implement partnership projects in Russia financed by the European Commission. In June, we organised a working meeting at the Foundation's headquarters of visa experts from Russia, Belgium, Germany, Moldova and Poland, to work on a report on visa relations between the EU and Russia to be published in 2015. During the 5th General Assembly of the Forum in Tallinn between 26 and 29 November, we presented conclusions from the works on the report on visa relations between the EU and Russia.

Within the framework of information activities targeted at citizens of the Eastern Partnership countries and Russia, we prepared visa guidebooks which explain in an easily understandable manner the procedure of applying for a visa to an EU member state as well as how specific groups of individuals may take advantage of existing facilitations in obtaining Schengen visas and effectively pursue their rights in consulates of EU member states. The guidebooks in Armenian, Azeri, Georgian, Russian and Ukrainian were published on the Coalition's website. Visa guidebooks were distributed during oneday street campaigns in front of consulates of EU member states in Minsk and Tbilisi and promoted during press conferences in Kyiv (November) and Yerevan (December).

In 2014, we continued our activities aimed at improving the quality of service of travellers at the crossings the EU eastern border.

We presented our recommendations concerning streamlining the functioning of the Polish part of the EU's external border in a panel discussion with the Commander-in-Chief of the Border Guard, representatives of Polish and Ukrainian custom services at a conference Polish-Ukrainian border. A chance or a barrier for social and economic development, organised on 27 March in Krasiczyn by the Polish-Ukrainian Chamber of Commerce. Arguments in favour of adopting a multiannual, detailed development strategy of state border were presented by us also on 3 April during a meeting of the Polish-Ukrainian Parliamentary Group in the Polish Parliament.

On 21 October, we organised a debate The border in times of crisis devoted to the functioning of the Polish-Ukrainian border during the Maidan revolution in the first months of 2014 and the assistance provided to Ukraine by Polish administration and non-governmental organisations. During the debate participated by representatives of the Border Guard, Customs Service, non-governmental organisations, the Polish Ministry of Foreign Affairs and Ministry of the Interior, Embassy of Ukraine and the Polish-Ukrainian Chamber of Commerce, we presented our report Polish border in the times of Ukrainian revolution, describing the functioning of the Polish-Ukrainian border in the most dramatic period of struggles between the authorities and the opposition in Kyiv in February 2014.

Eastern Debate Forum

We organise conferences, seminars and meetings attended by experts, politicians, and journalists from Eastern Partnership member states and from Russia. We offer space to discuss matters of concern to our eastern neighbours, their relations with the European Union and Russia, as well as priorities and directions in Polish and European Union eastern policies.

For obvious reasons, our 2014 meetings focused on the situation in Ukraine. We held two related conferences and four public debates on the subject.

On February 10, we organised a public debate, Maidan Questions, attended by Ukrainian journalists, politicians, and experts: Kateryna Horchynska (deputy Editor-in-chief at the Kyiv Post), Ihor Hryniv (Director of the Foundation for the Support of Economic Reform), Dr Oleksandr Lytvynenko (political sciences expert), and Vitaliy Portnikov (Editor-in-chief at TVi); the meeting was moderated by Mirosław Czech (Gazeta Wyborcza, Batory Foundation Board). Participants discussed the nature of Ukrainian protests and the Maidan phenomenon. The question of political and social processes triggered by Kyiv events was raised as well.

On February 26, we joined forces with the Solidarity Fund PL and the Civic Committee of Solidarity with Ukraine to organise the Maidan and Political Traditions debate attended by Prof. Myroslav Marynovych (deputy rector of the Ukrainian Catholic University in Lviv) and Yosyf Zisels (chairman of the Coordination Council of Jewish Associations, Organisations, and Communities, Public Committee for the Investigation and Prevention of Human Rights Violations). The meeting was moderated by Mirosław Czech (Gazeta Wyborcza, Batory Foundation Board) and Aleksander Smolar (President of the Batory Foundation). Debate subjects included Ukrainian identity and political traditions, threats of nationalism, and allegations of anti-Semitic tendencies resurging in the country. The event involved a presentation of Maidaner, an artistic project by Kristina Berdi.

On April 16, we organised a meeting with Serhyi Zhdan, a well-known poet, writer, and essayist: Ukraine in Reset. On Maidan, Anti-Maidan, and a country in need of change. We discussed Ukrainian developments from the Kharkiv perspective, including social, cultural, and language divisions, as well as relations between the Ukrainian central and peripheral territories, and Ukrainianism-Russianness contrasts. The meeting was moderated by Bogumiła Berdychowska (Więź guarterly).

On May 26, at the conference Ukraine 2014. Elections we presented results of the observation of an international civic expert mission for presidential election in Ukraine: Piotr Andrusieczko (delegated by the Batory Foundation) and Natalia Lynnyk (Commitee of Voters of Ukraine). The second part of the meeting involved a discussion panel (Elections – What now?) attended by Dr Kost Bondarenko (Institute for Ukrainian Public Policy), Volodimir Fesenko (Centre for Applied Political Studies Penta), and Oleksandr Sushko (Renaissance Foundation). The meeting was moderated by Bogumiła Berdychowska (Więź quarterly).

On June 13, in cooperation with the Renaissance Foundation from Kyiv we organized the Ukrainian Challenges conference. Part one, Politics as a challenge, was devoted to the Ukrainian political scene, relations between the government and the opposition/ Maidan, the role of the new president, and political radicalism. Speakers included: Mirosław Czech (Gazeta Wyborcza, Batory Foundation Board), Prof. Viktor Chumak (Director of the Ukrainian Institute for Public Policy), Oleh Medviedyev ("politechnologist" and journalist), and Andryi Shevchenko (deputy to Ukraine's Supreme Council). In part two, The Economy and the state as a challenge, panellists: Taras Kachka (independent expert), Irina Klimenko (Institute of Strategic Studies New Ukraine), Prof. Ihor Kolyushko (National University of Kyiv-Mohyla Academy), Dr Oleksandra Kuzhel (deputy to Ukraine's Supreme Council), and Marcin Święcicki (member of the Polish Parliament) discussed fundamental challenges faced by the Ukrainian economy (recession, debt, energy dependence on Russia), issues of corruption and oligarchy in the economy, as well as indispensable reforms and their political and social costs. The meeting was moderated by Bogumiła Berdychowska and Mirosław Czech.

Open Europe

On September 19, we organised the Radical Movements – Ukraine, Russia debate, with a keynote speech by Vyacheslav Lihachev, editor of the Anti-Semitism and Xenophobia in the Russian Federation bulletin, the Jews of Eurasia magazine, and historical programmes on the Ukrainian Inter TV channel. The meeting was moderated by Bogumiła Berdychowska (Więź guarterly).

Furthermore, we provided assistance to a group of Polish intellectuals attending an international conference Ukraine: Thinking together in Kyiv on May 16-19, with leading artists and intellectuals from Europe and the United States expressing their support for Ukraine's democratic and Europe-oriented efforts.

Video recordings and extensive descriptions of all public meetings have been uploaded to the Foundation's and YouTube websites. The meetings were reported in the media, e.g. Tygodnik Powszechny weekly published an interview with Yosyf Zisels and Myroslav Marynovych, Gazeta Wyborcza published the conversation of both our quests.

Furthermore, on January 8 we organised a roundtable on Russia Putin's Policy: the Experience and Perspectives with Ivan Krastev (head of the Centre for Liberal Strategies, Sofia) attende by politicians, journalists, and experts specialising in international affairs. The meeting was moderated by Aleksander Smolar (President of the Batory Foundation).

Club PL RU

In 2012, we established the Club PL RU as a platform for opinion exchange between representatives of Polish and Russian experts, publicists, and activists of the younger generation. Regular Club meetings are frequented by young political scientists, sociologists, economists, historians of ideas, and cultural anthropologists. Their discussions serve the purpose of learning about and comprehending the Polish and Russian ways of perceiving crucial social change, domestic policy, and international strategy issues, and of overcoming differences, bias, and stereotypes. Closed sessions are accompanied by public debates attended by Russian Club members.

In 2014, we organised two Club PL_RU meetings: in May – on the Polish and Russian comprehension of East European identity, and in October - on culture wars.

In the course of a meeting on May 19, young intellectuals (10 Russians and 13 Poles) discussed Polish and Russian East European attitudes: common history, historical and cultural relations, diverse attitudes towards Belarus and Ukraine, and Belarusian and Ukrainian identities. Ivan Preobrazhenskiy (political scientist and publicist) and Wojciech Przybylski (Editor-in-chief, Res Publika Nowa) gave keynote speeches.

The meeting was accompanied by a public debate: Russia +/-. What recent developments taught us about the country (May 20) attended by Oleg Kashin (journalist and publicist), Pawel Kazarin (regular contributor to Slon.ru and to the Rosbalt Information Agency), Ivan Preobrazhenskiy (political scientist and publicist), Michał Sutowski (editor at Krytyka Polityczna), and Dr Sergey Utkin (Institute of World Economy and International Relations). The debate was moderated by Dr Karolina Wigura, (Kultura Liberalna, Batory Foundation Board). Panellists discussed changes to Russia in the wake of the Crimean annexation and of the east Ukrainian conflict.

In the course of the Club's autumn session (October 27), 14 young Russians and 16 Poles debated Polish and Russian ideological disputes concerning lifestyle, family paradigms, values, and cultural role models. Attendants deliberated on whether and how such disputes make their way into public debate and art. Ivan Preobrazhenskiy and Karolina Wigura, gave keynote speeches.

The Club meeting involved a public debate: Russia: a conservative turn? (October 28) attended by Russian Club members: Dr Aleksandr Bikbov (Lomonosov Moscow State University), Dr Ilya Kalinin (cultural historian), Pawel Kazarin (regular contributor to Slon.ru and to the Rosbalt Information Agency), Dr Artyom Magun (University of Strasbourg), and David Ter-Oganyan (visual artist and curator). The meeting was moderated by Dr Karolina Wigura (Kultura Liberalna, Batory Foundation Board).

Electronic and traditional media reported on meetings and published interviews with Russian Club members (e.g. Znak monthly published an interview with Ivan Preobrazhenskiy, Tygodnik Powszechny printed an interview with Oleg Kashin).

Election monitoring in Eastern Partnership countries

Expert mission to presidential elections in Ukraine

Together with the European Exchange from Germany and the Promo-LEX Association from Moldova we organised an International Expert Mission to May 25 Ukrainian presidential elections. A team of electoral observation specialist from Spain, Poland, and Russia provided assistance to Ukrainian non-governmental organisations Committee of Voters of Ukraine, and the Civil Network "OPORA" engaged in independent election monitoring.

The ambassadors of the mission included Janusz Onyszkiewicz (former Polish defence minister, member of Polish Parliament and former MEP) and Werner Schulz (former Bundestag member, MEP) who took honorary patronage over the Expert Mission. The mission was organised within a framework of the European Platform for Democratic Elections, a coalition of thirteen non-governmental organisations from EU Member States, EaP countries and Russia, engaging in election monitoring. It was funded from a grant provided by the European Commission.

Election monitoring results were presented on May 26 in Warsaw by Polish and Ukrainian participants of the mission. On May 27, a press conference with Janusz Onyszkiewicz on election procedures and practices was held at the Polish Embassy in Kyiv.

Civic monitoring of election campaign finance in Moldova parliamentary elections

In cooperation with the Moldovan Promo-LEX Association, we were engaged in monitoring of electoral campaign finance during November 30 parliamentary elections in Moldova. The project, implemented with the support from the Solidarity Fund PL, tapped on past experience of the election campaign monitoring we carried out in our Anti-Corruption programme.

The project involved: adaptation of the Polish methodology of electoral campaign finance to the specificity of local elections in Moldova, training the observers of Moldovan elections to monitor election campaign finances, organising a Polish expert mission, supervising the implementation of finance monitoring by Moldovan partners and assisting them in their efforts to disseminate the observation

results and develop recommendations on the ways to prevent irregularities in election campaign financing.

The activities undertaken within the project included: a study trip to Poland for 10 Moldovan coordinators of the electoral monitors accompanied by a training session and workshop on the methodology of electoral campaign finance monitoring (June 30–July 4); training sessions in Chisinau for 50 observation team members: mission management, regional coordinators, and long-term observers (September 14 and 27); public debates on issues related to election campaign financing (September 15 in Chisinau, and October 2–10 at six other Moldovan locations).

A Batory Foundation electoral expert mission: Agnieszka Kozłowska-Rajewicz (MEP), Paweł Kowal (former MEP, former vice-minister of foreign affairs), and Adam Sawicki (expert on electoral campaign finance) travelled to Moldova for a period of November 26-December 2. They met with the representatives of observation missions organised by the OSCE/ODIHR, National Democratic Institute and US-AID, and participated in the presentation of the fourth interim report on social monitoring of election campaign finance drafted by the Promo-LEX Association. On election day, mission members joined short-term observer teams in the Transnistrian and Gagauz regions. On December 1, expert mission members took part in a presentation of reports from monitoring conducted by the civic observation mission organised by Promo-LEX Association.

Other activities

Study visit of the Georgian think-tank representatives in Poland

On June 23–27 2014, we organised a study visit for two representatives of Georgian's Reforms Associates GRASS think-tank. They met representatives of the Centre for Eastern Studies, Polish Institute of International Affairs, European Council on Foreign Relations, demosEuropa, Ministry of Foreign Affairs, and the Municipal Council of the City of Cracow. The purpose of the visit was to exchange experience in such fields as operating analysis centres in Poland and Georgia, cooperation of NGOs with authorities, and fundraising for the think-tanks. The visit was funded by the the East-West Management Institute from USAID resources.

In 2014, the programme was funded from funds provided by the Open Society Foundations (PLN 274,799.35), grants from: the Solidarity Fund PL (PLN 179,334.58), the National Endowment for Democracy (PLN 113,035.58), the Centre for Polish-Russian Dialogue and Understanding (PLN 25,000), the European Commission via the German-Russian Exchange (PLN 21,778.53), the Georgian department of the East-West Management Institute (PLN 6,706.33), and from the Foundation's own resources.

ECFR Warsaw Office

The European Council on Foreign Relations (ECFR) is a part of a pan-European think tank operating since 2007 in seven European Union capitals. ECFR's objective is to conduct research and promote informed debate across Europe on the development of coherent and effective European values-based foreign policy. ECFR each year issues publications on topics related to European Union foreign policy, prepares reports and analyses, and organizes conferences and public debates, seminars, and expert discussions.

In 2014, activities of the ECFR Warsaw focused on disseminating reports prepared by ECFR experts and organising meetings (both debates open to the wider public and closed expert meetings). We organised 24 meetings, including 12 expert seminars and 12 public debates.

Debates and Seminars

On January 4, we organised an expert seminar: Europe's Migration Challenge: Confronting Populism, Rethinking Policies with commentaries by Maciej Duszczyk (Institute of Social Policy, University of Warsaw), Heather Grabbe (Director, Open Society European Policy Institute), Henryka Mościcka-Dendys (undersecretary of state for parliamentary affairs, European policy, and human rights, Ministry of Foreign Affairs), Jordi Vaquer (Director, Open Society Initiative for Europe), and Jakub Wiśniewski (Director, Foreign Policy Strategy Department, Ministry of Foreign Affairs).

On February 11, we held a public debate European Foreign Policy Scorecard: The Changing Nature of European Leadership: Big Three and Poland in the EU Foreign Policy, involving promotion of the EU Foreign Policy Scorecard 2014 report. The debate was attended by Hans Kundnani (ECFR, co-author of the European Foreign Policy Scorecard), Christine Ockrent (journalist, member of the ECFR Council), Jan Techau (Carnegie Europe, Brussels), and Jakub Wiśniewski (Director, Foreign Policy Strategy Department, Ministry of Foreign Affairs).

On March 18–19, in cooperation with the Foundation for Polish-German Cooperation we organised an expert seminar and public debate on the future of the Eastern Partnership: Preserving European Choice: What Next for the EU Eastern Neighbourhood. Andrew Wilson (ECFR), Nicu Popescu (European Union Institute for Strategic Studies), and Jana Kobzova (European Endowment for Democracy) gave keynote speeches.

On April 2 and 3 we, in cooperation with the Centre for Polish-Russian Dialogue and Understanding, we organised an expert seminar and public debate on EU–Russian relations in the context of Ukrainian circumstances: EU–Russia Relations: Where Do We Go from Here? Discussion participants included Adam Eberhardt (Eastern Studies Centre, Warsaw), James Sherr (Chatham House, London), Marie Mendras (Sciences Po, Paris), and Sergey Utkin (Russian Academy of Sciences, Moscow).

On April 24, in cooperation with the Krytyka Polityczna editorial staff and the Friedrich Ebert Foundation, we organised the Germany: Foreign Policy at a Crossroads debate. Attendants included Jörg Lau (Die Zeit), Hans Kundnani (research Director at the ECFR), and Anna Kwiatkowska-Drożdż (Centre for Eastern Studies).

On May 12, we joined forces with the European Commission Representation Office in Poland and the Ministry of Foreign Affairs in organising an expert seminar (In)Completed Eurozone – Challenges Ahead on eurozone reform and the economic crisis in Europe. Debate panellists included Piotr Serafin (undersecretary of state, Ministry of Foreign Affairs), Hans Geeroms (Belgian National Bank), Karolina Leib (European Commission), Wolfgang Merz (German Federal Ministry of Finance), and Daniela Schwarzer (German Marshall Fund).

On May 14, we organized a public debate This Time Is Different: How the EP Elections will Change EU Politics. The panellists: Ignacio Toreblanca (ECFR expert, Madrid), Ulrike Guerot (Open Society Initiative for Europe), and Rene Cuperus (Wiardi Beckman Foundation from the Netherlands) and other attendants deliberated on how European Parliamentary elections will serve to alter European Union policies.

On June 25 in cooperation with the Konrad Adenauer Foundation and the Polish Confederation Lewiatan we organised an expert seminar EU Foreign Policy: Time to Grow Up? Agenda for the New High Representative. The seminar focused on key challenges to the European Union's foreign policy, including the European Neighbourhood Policy and the Common Foreign and Security Policy. Francesco de Borja Lasheras (ECFR), Nick Witney (ECFR), Rem Korteweg (Centre for European Reform), and Vivien Pertusot (Institut Francais des Relationes Internationales) gave keynote speeches.

On July 1, together with the Polish Institute of International Affairs we organised an expert meeting on how German foreign policy is received in Europe and Poland: Perception of Germany as an Ally and Partner. The meeting was attended by Claudia Major (Stiftung Wissenschaft und Politik, Berlin), Ryszarda Formuszewicz (Polish Institute of International Affairs), and Ann-Kristin Otto (German Ministry of Defence).

On September 23–24, we held an expert seminar and public debate on the political situation in Turkey in the wake of presidential elections and on Turkey-EU relations. The speakers of the debate included Dimitar Bechev (author of the ECFR's publication Turkey's Illiberal Turn), Gokhan Bacik (Turkey Institute, Ankara), and Pinara Elmana (Polish Institute of International Affairs. The seminar was organised in partnership with the Africa and Middle East Department of Polish Ministry of Foreign Affairs, the public debate was a joint event with Polish Institute of International Affairs.

On September 26, in cooperation with the Heinrich Boell Foundation in Warsaw, we inaugurated a series of Diplomatic Morning Briefings for diplomats from EU member states, experts, and business sector representatives. The first meeting with a special guest Michael Rühle (Head of the Energy Security

mit in Newport, Wales, and challenges concerning relations with Russia.

On October 2, during the 3rd European Forum of New Ideas organised in Sopot, Poland by the Polish

Section, NATO Headquarters), focused on the future of NATO, decisions taken at the September Sum-

On October 2, during the 3rd European Forum of New Ideas organised in Sopot, Poland by the Polish Confederation Lewiatan, we prepared a panel Challenges Ahead of the EU After the Elections: Euroscepticism and Geopolitical Changes. on political and social challenges facing the European Union after the European Parliamentary elections and new European Commission appointments: The participants of the panel included: Danuta Hübner (ECFR Council member, MEP), Pierre Buhler (French Ambassador to Poland), Mark Leonard (Director, ECFR), and Henri Malosse (President of the European and Social Committee).

On October 8–9, in cooperation with demosEUROPA and the Friedrich Ebert Foundation in Warsaw we organised an expert seminar and public debate on EU-Asian relations Europe in the Asian Century. Key note speakers included: Bernt Berger (Institute for Security and Development Policy, Stockholm), Angela Stanzel (expert on Asia at the ECFR), Axel Berkofsky (University of Pavia, Italy), Marjut Hannonen (European Commission), and Hans Kundnani (research Director, ECFR).

On October 13, together with the German Embassy in Poland, we held an expert seminar on changes in German foreign policy. The seminar was accompanied by a public debate co-organised with the Institute of Public Affairs. Thomas Bagger (Director, Planning Department at the German Ministry of Foreign Affairs) was a special guest at both meetings.

On November 5, we co-organised an expert seminar on the political situation in Tunisia and other North African states with the Africa and Middle East Department of the Polish Ministry of Foreign Affairs. Anthony Dworkin (ECFR), author of the Tunisia's Elections and the Consolidation of Democracy was the meeting's special quest.

On November 6, together with the New Eastern Europe's editorial staff, we held a public debate on the political situation in Ukraine in the wake of parliamentary elections. Tha panellists included: Andrew Wilson (ECFR expert, Senior Fellow), Paweł Kowal (member of the editorial council at New Eastern Europe), Andrzej Szeptycki (University of Warsaw), and Tatyana Pushnova (TV producer at Ukraine Today).

On November 12, the participants of the Diplomatic Morning Briefing discussed the European Union's climate and energy policies with the special guest, Georg Zachman of the Bruegel Institute (Brussels). On December 2, a subsequent Diplomatic Morning Briefing focused on the economic situation in the European Union with Wolfgang Munchau (member of the ECFR Council, Financial Times commentator) as a guest speaker.

On December 4, we held an expert seminar Towards European Strategic Convergence: East-Southwest Synergies and the Role of Poland and Spain. The participants included Francisco de Borja Lasheras (ECFR), Alejandro Humanes Laplaza (Ministry of Defence, Spain), Eva Martinez Sanchez (Director for Maghreb, Spanish Ministry of Foreign Affairs), Henryka Mościcka-Dendys (undersecretary of state, Ministry of Foreign Affairs), and Agustin Nunez Martinez (Ambassador of the Kingdom of Spain to Poland). The meeting was hosted by the Royal Spanish Embassy in Poland.

On December 5, we organised a public debate The End of Military Involvement? Polish and European Perspectives of Liberal Interventionism. The issue of the European Union's global military involvement

was discussed by Nick Witney (expert, ECFR), Sylvie Kauffmann (Le Monde), and Roman Kuźniar (international affairs advisor to the President of the Republic of Poland). The meeting was coorganised by the Austrian Embassy in Poland, and hosted by the Austrian Cultural Forum.

On December 11 together with the Polish Institute of Diplomacy and the Centre for International Relations, we co-organised a public debate Iran, Gulf and the Unravelling Middle East. Political and Economic Perspectives on the EU perception of Iran's nuclear programme, and the EU related political and economic cooperation with Persian Gulf countries. The debate was attended by Małgorzata Bonikowska (THINK TANK), Ellie Geranmayeh (ECFR expert on Iran), Patrycja Sasnal (Polish Institute of International Affairs), Piotr Kozłowski (Ministry of Foreign Affairs), and Andrew Hammond (expert, ECFR).

Publications

In December, the ECFR published *Poland after Tusk*, an analytical essay by Piotr Buras, Director of the ECFR Warsaw Office, on Poland's position in the European Union ten years after Polish accession to the European community.

In 2014, ECFR Warsaw Office operations were funded from the funds provided by Open Society Foundations.

Regional Alcohol and Drug Programme

The aim of the program is to share Polish experience in prevention and treatment of alcohol and drug addiction with professionals from the countries of Central and Eastern Europe and Central Asia. Our seminars, workshops, internships, and conferences offer education and training to the addiction counselors from the region. We also support publication of popular literature on the methods of treatment based on partnership of the professionals and AA and Al-Anon. Our activities include workshops for trainers skilled in reeducation of domestic violence offenders.

Atlantis: treatment of alcoholics in penitentiary institutions

Since 1991, Poland has successfully applied a model of addiction treatment in correctional facilities. Rehabilitation of alcoholics is based on the program of Alcoholics Anonymous and cooperation with the AA community. We share Polish experiences with other countries organizing workshops and internships for penitentiary staff. We cooperate with the representatives of justice ministries in Ukraine, Lithuania, Bulgaria, Moldova, Georgia, Armenia, Kyrgyzstan, Latvia, Estonia, as well as Siberia and the Russian Far East.

In May 2014, three experts of our programme attended a conference in Bishkek organised to mark the th anniversary of the Atlantis programme in Kyrgyz penitentiary facilities. In September, we organised a regional Summer School in Riga for penitentiary personnel, attended by 50 prison guards and therapists. In December, we organised a visit to Warsaw for delegates of the Georgian Ministry of Justice headed by the Georgian vice-minister for penitentiary reform.

Training courses and internships

In 2014, we organised two training courses in Poland: Aggression Replacement Training (March), and a workshop for addiction therapists (June). We held 15 workshops and seminars abroad, i.a. in Ukraine, Bulgaria, Lithuania, Georgia, and Russia. We also organised a series of training sessions for Polish émigrés to West European countries on issues of alcoholism and family pathology (i.a. in Oslo, Dublin, and Paris). Furthermore, we organised internships for 24 therapists from eastern countries at addiction therapy centres in Poland and a study trip for Directors and staff of Russian addiction therapy units.

Regional Alcohol and Drug Programme

Conferences

We provided funds enabling two consultants (from Poland and Hungary) to attend an international conference on Employee Assistance Programmes in Dublin. After having attended the conference, the Polish delegate delivered two lectures and held a workshop on early alcoholism detection for participants of the all-Polish Medical Air Rescue convention.

Publications and media

We co-funded a programme on addictions broadcast on the Bajka [Fable] radio, targeting kindergarten children and their parents. Programmes are scheduled for the first quarter of 2015. We financed translation of the Wiktor Osiatyński's book Rehabilitation into the Bulgarian language.

In 2014, the programme was financed by a grant from the Open Society Foundations.




Structure of expenditures
