### ***Biography notes of members of the Stefan Batory Foundation's Legal Expert Group***

**Łukasz Bojarski**, president and co-founder of the INPRIS Law and Society Institute. In 2010-2015, member of the National Judiciary Council and employee at the Helsinki Foundation for Human Rights. Member of editorial boards of the *Kwartalnik Krajowa Rada Sądownictwa* and *Na Wokandzie* quarterly magazines. One of the founders and Chair of the Board of the Legal Clinics Foundation. Polish expert in the European Network of Legal Expert in the Non-discrimination Field. Author of papers in the area of legislation, the judiciary, legal aid and interactive methods of teaching law.

**Jacek Czaja**, president of the Legal Society. Former expert of the International Law Development Institute in Rome, Italy, and member of the USAID Legal and Regulatory Reform Project. He contributed to the reform of business courts in several Central and Eastern European countries. In 2007-2011, he was Undersecretary of State in the Polish Ministry of Justice. Member of the Expert Board of the Citizens and Law programme of the Institute of Public Affairs.

**Dr. Aleksandra Gliszczyńska-Grabias**, associate professor at the Poznań-based Human Rights Centre of the Institute of Legal Studies of the Polish Academy of Sciences. Fellow of the Yale University, University of Cambridge, the Hebrew University, the Foundation for Science and the Ministry of Science and Higher Education. Council of Europe expert in the Help in the 28 programme, member of the Science Board of the Democratic Community. She specialises in international human rights protection systems, antidiscrimination law, conflict between freedom of speech and hate speech, transitional justice and 'memory laws'.

**Dr. Piotr Kłodoczny**, lecturer at the Department of Law and Administration of the University of Warsaw. He has worked with the Helsinki Foundation for Human Rights since 1996 where he has lead legal and intervention programmes. Currently, member of the Foundation. He has written a number of publications on criminal law, criminal proceedings, executive criminal law and drug policies.

**Dr. Marcin Matczak, professor at the University of Warsaw**, lawyer and lecturer at the Faculty of the Philosophy of Law and State Science at the University of Warsaw, partner at Domański Zakrzewski Palinka law firm. He has authored over fifty publications including two monographs: *Summa iniuria. O błędzie formalizmu w stosowaniu prawa* and *Kompetencja organu administracji publicznej*. He specialises in pharmaceutical, administrative, advertising, biotechnology, anti-monopoly law and regulatory consulting. Contributed to legislative reviews by assessing the constitutionality and alignment with international laws.

**Dr. Tomasz Pietrzykowski, professor at the Silesian University**, professor at the Faculty of the Theory and Philosophy of Law at the Department of Law and Administration, Silesian University in Katowice. In 2005-2007, he was the Governor of the Silesian Province. Since 2009, co-chair and since 2015, member of the National Ethical Committee for Animal Experimentation in the Ministry of Science and Higher Education. Since 2004, legal counsel, member of the editorial board and programme board of the *Radca Prawny* journal. In 2010-2013, member of the Ethics Committee of the National Bar of Legal Counsels. Since, 2014, chair of the Board of the College of Individual Interdisciplinary Studies at the Silesian University. Author of numerous books and articles including *Etyczne problemy prawa* (2011), *Wsteczne działanie prawa i jego zakaz* (2004), *Etyka w administracji publicznej* (jointly with I. Bogucka, 2009), *Ujarzmianie Lewiatana. Szkice o idei rządów prawa* (2014).

**Prof. Fryderyk Zoll**, professor at the Jagiellonian University and University in Osnabrück. Doctor honoris causa of the National University of Economics in Tarnopol, Ukraine. Member of the Committee of Legal Studies of the Polish Academy of Sciences. In 2011-2015, member of the Civil Law Codification Committee.
