Nikos Passas is Professor of Criminology and Criminal Justice at Northeastern University. His degrees are from the Universities of Athens, Paris-II and Edinburgh. He is also Distinguished Visiting Professor at Beijing Normal University; Distinguished Practitioner in Financial Integrity at Case Western Reserve Law School, Chair of the Academic Council of the Anti-Corruption Academy in India, and member of the Advisory Board of the Centre for Crime, Justice and Policing at the University of Birmingham.

He is fluent in 6 languages and has more than 240 publications on corruption, good governance, illicit financial/trade flows, sanctions, informal fund transfers, remittances, terrorism, and financial regulation. His main current project, supported by the Natl Science Foundation, focuses on the detection and disruption of illicit and falsified medicinal products. He consults with law firms, financial institutions and various organizations, including the UN, EU, OECD, OSCE, IMF, the World Bank, research institutions and government agencies in all continents. He serves on the Board of Directors of Compliance and Capacity Skills International in New York, the Advisory Board of the Global Risk Profile in Geneva, the International Panel of Advisors at the Institute for Australia India Engagement in Brisbane and as Co-Chair of the Steering Committee of the University of Geneva Anti-Corruption Academy (GENACA).

Ionuţ Sibian is the executive director of the Civil Society Development Foundation (FDSC), one of the most influential NGOs in Romania. After Romania's accession to the European Union in 2007, Ionuţ Sibian was elected to represent the Romanian NGOs in the European Economic and Social Committee (EESC). His previous experience includes: President of the Romanian Federation of Development NGOs (FOND), Board member of the German Marshall Fund programme - Black Sea Trust and member of various Boards of Romanian and European organisations. Foundation Board.

Marcin Walecki



Dr Marcin Walecki has since October 2020 been a new Director of EUROPAEUM, an association of Europe's leading universities founded in 1992 by Oxford University. A Polish national, he has over 25 years of democracy support and governance experience working in more than 50 countries around the world. Before joining EUROPAEUM he was a Head of Democratization Department of the Office for Democratic Institutions and Human Rights OSCE/ODIHR (www.osce.org/odihr), one of the

world's principal regional human rights bodies. He was also the first Executive Director of the European Partnership for Democracy (www.epd.eu), a not-for-profit organisation with a global remit to support democracy, that brings together a network of leading European organisations specialising in the different parts of a democratic system. From 2004 to 2009 he was a Senior Adviser for Political Finance for IFES (www.ifes.org), responsible for designing and implementing programs to combat political corruption, securing electoral integrity, and regulating political finance. Marcin holds degrees from the Department of Law and Administration at the University of Warsaw (MA in Law Hons, Class I) and Oxford University (DPhil from St Antony's College). He is a former Max Weber Fellow at the European University Institute in Florence and a Senior Associate Member of St. Antony's College. As an academic, he has a strong interest in democratic governance, rule of law, political parties, elections, and political corruption.

Dr Janine R. Wedel Janine R. Wedel (Twitter a@janinewedel), is an award-winning author, social anthropologist, and University Professor in the Schar School of Policy and Government at George Mason University (also Fellow at the Hertie School of Governance in Berlin). She writes about corruption, governance, elites, and informal networks and for nearly four decades has conducted field research on both sides of the Atlantic, focusing on Central and Eastern Europe and the United States.

Her most recent book, Unaccountable: How the Establishment Corrupted Our Finances, Freedom, and Politics and Created an Outsider Class (paperback & kindle editions 2016), was named in Bloomberg's survey of 2014 favorite reads. Other prizewinning books include Shadow Elite: How the World's New Power Brokers Undermine Democracy, Government, and the Free Market (2009); and Collision and Collusion: The Strange Case of Western Aid to Eastern Europe (2001).

A public intellectual, she has contributed analysis pieces to more than a dozen major outlets, including the Financial Times, New York Times, Washington Post, USA Today, and the Wall Street Journal Europe, and her work has been reviewed or translated into more than a dozen languages. A five-time Fulbright fellow, she has also won the Grawemeyer Award for Ideas Improving World Order, as well as major awards from the National Science Foundation,



MacArthur Foundation, and Institute for New Economic Thinking, among many others. Wedel is co-founder and past president of the Association for the Anthropology of Policy (ASAP), a section of the American Anthropological Association.
