
# Transversal collaboration for civil society networks







# It allows us to focus on advocacy for social and affordable housing







### WHY network transversal collaboration

- bridging gaps between various people, organizations, institutions, their interests, approaches and views in the polarised society
- **networks** in civil society are natural bridges between individuals and collective action efforts
- by engaging with diverse stakeholders systemic changes could be started/progressed/resolved (and gaps potentially reduced)

### **Network transversal collaboration**

#### The goals of the Call for Proposals:

- to strengthen the collaboration and develop closer relationships between the civil society networks and a diverse external stakeholders
- to enhance internal development and closer collaboration among the network's member organizations

**Both areas are equally important!**

## What IS network transversal collaboration

- concept developed by Glopolis in 2019 as part of the Stronger Roots Program
- process of civil society networks strategically engaging with stakeholders of diverging approaches, interests and/or worldviews in order to tackle collectively the complex and systemic issues that our societies or communities face

# How to look for diverse stakeholders?

- differences can be seen in the interests, approaches, perspectives or **priorities** regarding a certain issue the network is trying to solve
- there are varying objectives, values, or levels of influence
- the gaps could also be ideological, political, inter-sectoral (between civil society, business or government), regional and generational

# What IS NOT network transversal collaboration (1/2)

- NOT about persuading others about our truth but rather finding a common denominator or shared agreement (especially relevant for advocacy networks)
- NOT about target groups but rather (potential) partners respecting their interests, needs and limitations













# What IS NOT network transversal collaboration (2/2)

- NOT a one-off project but rather a long-term effort of building the relationships and constructively engaging with the stakeholders
- NOT about raising awareness nor education but rather about tangible effects of engagement with limited number of most relevant people (quality vs. quantity)

### **Choosing the stakeholders**

Aim to engage systematically with diverse, domestic stakeholders, from these areas:

- state institutions, members of parliament
- regional authorities, local municipalities
- private companies, business associations
- other civil society organizations or networks











## **Collaboration/engagement outside** the network scale

The level of enegagement depends on various factors: topic, divergency of partners, stage of the discussion,...

### Internal consolidation of the network

All activities leading to more impactful, resilient network that is capable of meaningful engagement with its member organizations.

activities should contribute to the strategic goals of the network (advocacy • goals, capacity building goals etc.)

activities should reflect current needs of the network and its members 











## Tips for writing the proposal (1/3)

- KNOW your long-term vision of the collaboration and internal development -Where should it lead after the project ends? What is the ultimate goal?
- THINK about what your network needs the most to get stronger in next 2 years.
- · FOCUS on goals and activites which are achievable in 18 months What will the project contribute to in this vision? What are the project's specific goals, and how can they be achieved?











# Tips for writing the proposal (2/3)

- THINK about the stakeholders' interests Why should they be willing to collaborate? What interests do you share? What are their views and potential motivations?
- THINK about the stakeholders' needs What do they need? What are they struggling with? What can they gain from the collaboration? What can you do to ensure their engagement is meaningful rather than just formal?











# Tips for writing the proposal (3/3)

- FOCUS on qualitative engagement rather than quantitative It is more effective to engage fewer stakeholders more deeply, rather than simply aiming for higher numbers.
- ANSWER all the sub-questions in the concept note form They are all important!











### **Expected results of the project**

- Have to be specific and clear.
- Need to have impact on the society or community.
- What will change thanks to the project? **Examples**:
- Ministry XY will adopt a new policy on... ٠
- Our network will become more participatory in terms of small members' participation in decision-making within the network...











#### Will the project contribute to...?

Key questions to ask yourselves to make sure you are meeting the expected results.

- ...progressing the strategic goals of the network?
- ...improving the relationship/advancing engagement with the chosen stakeholders?
- ...broadening of your understanding of the context, in which your network operates, and of the ways of working with the stakeholders?
- ...internal consolidation of the network?

# **Stronger Roots Program impact (1/2)**

#### Thanks to the Stronger Roots Program supported networks are able to:

- better understand the partners they engage with
- discover new ways to reach out to and build relationships with both current and potential new partners
- initiate cooperation with entirely new types of actors
- adopt more flexible and open approaches











# Stronger Roots Program impact (2/2)

#### Thanks to the Stronger Roots Program the grantees are able to:

- let go of preconceived notions about the impossibility of collaborating with public authorities
- work together even without 100% mutual agreement or alignment
- better understand the needs and priorities of their member organizations

# **Application guidelines and eligibility** criteria for Pillar 2

- Program for CSOs platforms, coalitions and networks (formal and informal)
- Strengthening collaboration with divergent stakeholders
- Building the network internally











### **General conditions**

- One proposal per organisation can be submitted
- Budget must be in between 20.000 EUR 35.000 EUR
- Duration of the grant is 18 months: January 2026 June 2027
- We expect to support 4 10 projects in each country











### **Eligible activities**

#### **Engaging with diverse external stakeholders**

- organizing meetings, events, strategic debates, workshops or negotiation processes
- mapping stakeholders and collecting evidence for joint activities
- involving indifferent or opposing stakeholders in joint action
- events or processes building or improving relationships stakeholders
- building or expanding the coalitions of divergent stakeholders
- international activities within the EU in well justified cases

### **Eligible activities**

#### Internal consolidation of the network

- review of network's strategies, statutes and
   engage
   internal processes
- building a consensus among members
- building capacities for crisis communication
   and crisis management, mediation
- expanding membership activities





engaging the members in co-designing the network's objectives, strategy, impact measurement, evaluation or communication
activities to support members with specific needs (especially small, less formal, younger and out-of-capital members)









### **Eligible costs**

- personal costs (up to 80% of a grant)
- cost for goods (careful with the depreciacion), works and services (including external experts)
- travel, accommodation and subsistance
- indirect costs (up to 7% of a grant)
- costs must occur within the period of project implementation
- must comply with national law on taxes, labour and social security
- must be reasonable, justified, cost-effective

### **Eligibility criteria**

- CSOs from Czechia, Hungary, Poland and Slovakia
- Network registered or existed for at least 6 months as a legal entity or its member organisation registered 1 year prior the deadline
- Having at least 7 civil society member organizations in the given country
- Mission and activities must comply with the EU's rights and values
- Project leaders must have the capacity to communicate and participate in events in English
- Not previously received grant for Transversal collaboration of networks













#### **Definition of networks and members**

- Networks can be:
  - **B.** Formal (registered)
  - **C.** Informal (non-registered, but record of cooperation within recognised platform)
- Members must be:

At least 7 unique independent CSOs

(not independently registered units within the same organisation - e.g. Scouts)











### **Non-eligible organisations**

Political party-affiliated associations, public sector, governmental and intergovernmental institutions, religious institutions, profit distributing cooperatives or informal groups are not eligible to apply for our support. Neither a sole proprietorship nor a natural person is an eligible project applicant.

### **Application process**

Two stages:

- **1.** Concept note
  - Proposal
  - Annual report 2024 or summary of activities
  - Financial report 2024 or financial overview

2. Full application - more elaborated project with detailed budget for selected organisations + incorporating feedback

#### **Evaluation process**

- Administrative check
- Eligibility check
- Evaluation based on set criteria
  - (for full application stage + interviews for shortlisted)











### **Evaluation criteria**

- Relevance of the Project for this Call (20 points)
- Transversal Collaboration Focus (25 points)
- Potential of the Network, Internal Strengthening, and Project Impact (25 points)
- Quality of the Project (30 points)

Maximum points: 100 Threshold: 60 points











### **Timetable**

- Consultations: up to 10 June 2025
- Deadline for concept notes: **16 June 2025 13:00 !!!**
- Administrative and eligibility check: until the end of June
- Evaluation process: July August (evaluators + committee)
- Full application: September October (including info webinar)
- Evaluation process: October November (including interviews)
- **Results:** November
- Contracting successful organisations: November December (grant: 60% + 30% + 10%)
