





Strengthening democracy and the rule of law in Europe in face of polycrises

Polish "Civil EU Presidency"

Today Europe grapples with complex and interconnected crises - including climate change, widening economic precarity, and increased sense of insecurity following the Russian aggression on Ukraine and the change of approach of the US administration. At the same time as these crises are unfolding, we are also witnessing the deterioration of trust in democracy itself and in institutions' capacity to protect fundamental rights and address people's needs. Deterioration of social cohesion and disillusionment with institutions' ability to protect fundamental rights and meet people's needs are among the most pressing threats of our time, as they are leaving societies vulnerable to internal and external actors seeking to dismantle democratic principles, the rule of law and the universality of rights.

In this context, a robust civil society is instrumental in strengthening our democracies vis-à-vis these challenges, in its everyday action for just, inclusive and sustainable societies. Civil society plays a crucial role in fostering and protecting European values, rule of law, democracy, fundamental rights and equality across Europe; building European public space and participatory democracy; and mitigating the social costs of multifaceted crises. However, civil society across Europe is increasingly facing restrictive regulations and funding policies, as well as political pressure that hinders its capacity to effectively act and advocate for democracy, fundamental rights and the rule of law.

This conference, building on the conclusions of the <u>Civil Society Forum</u> held in Warsaw on 26 June 2024 and the <u>Civil EU Presidency</u> organised by civil society shadowing the official Hungarian EU Presidency in the fall 2024, will bring together civil society representatives from Poland and from across Europe, including the Western Balkans, EU and Polish policymakers, as well as donors. It will provide an opportunity to inspire EU policy agenda for the next five years in areas such as the defence of democracy, the rule of law, an EU civil society strategy and how these are supported through the Multiannual Financial Framework (MFF). The outcomes of this debate will particularly be handed over to the Danish, Cypriot, and Irish civil society in order to inform the priorities of the respective upcoming EU Presidencies.
